PRESIDENT: Looks like general file begins with the debate of LB 319A.

CLERK: Legislative Bill 319A. Introduced by Senator Richendifer of the 16th district. (bill read)

PRESIDENT: Chair recognizes Senator Richendifer.

SENATOR RICHENDIFER: Mr. President and Members of the Legislature. This is the A bill that goes with 319 to provide the funds for the computerization. I move that it be advanced to E&R initial.

PRESIDENT: Any further discussion of the bill? 319A. Question is--are you all through debating the bill? Senator Nore do you have a question? Senator Nore.

SENATOR NORE: Mr. Chairman, I'd like to ask a question-- Mr.--or Senator Richendifer. Is this a cash account?

PRESIDENT: Senator Richendifer, Senator Nore has a question for you and he wants to know if this is a cash account or not.

SENATOR NORE: Strictly cash fund?

SENATOR RICHENDIFER: The money that, that comes from the abstracts, Senator Nore, goes into the general fund and this is just a means of withdrawing them back for the computerization.

SENATOR NORE: Is it self supporting?

SENATOR RICHENDIFER: This will be self supporting if we can get it across, 319 across the board.

PRESIDENT: Any further questions? Question is shall LB 319A be advanced from general--Senator Richendifer? All right. When that little light goes on I respond.

SENATOR RICHENDIFER: Well maybe I should--I thought Senator Goodrich was in here. I was going to ask for a consent to reconsider 319 on general file and start that again.

PRESIDENT: Well, that's not in order here right now. Question is shall LB 319 be advanced from general file to E&R initial? All those in favor vote aye. All those opposed vote no. Voting on the advancement of LB 319A from general file to E&R initial. Well, gentlemen, have you all voted? Senator Richendifer.

SENATOR RICHENDIFER: I'd ask for a call of the house.

PRESIDENT: Senator Richendifer asking for a call of the house. Clerk will clear the board. 319A. General file. Clerk will clear the board. Senator Richendifer has asked for a call of the house. Please indicate whether you support a call of the house or not. All those in favor vote aye. All those opposed vote no. Motion is for a call of the house. Senator Richendifer asking for a call of the house. Have you all voted? Clerk will record.

CLERK: 22 ayes, Mr. President to go under call.

PRESIDENT: I would now remind the body that we're under a call of the house. Will you please take your seats? The issue under debate and motion is LB 319A. Shall it be moved from general file to E&R initial. All those in favor vote aye. All those opposed vote no. Senator Chambers voting aye.

CLERK: Senator Simpson voting aye on the original motion.
