PRESIDENT: Chair recognizes Senator Clark for his motion on 397. Chair recognizes Senator Clark for his motion on LB 397.

SENATOR CLARK: A Mr. President, members of the body. 397 is on engrossing in it.

PRESIDENT: Yes.

SENATOR CLARK: I would move to return it to select file for specific Amendment, and I think the Clerk has the Amendment.

CLERK: The Amendment would add a new section and Amend 66-428. The only word change, is the changed use, to read users, of Motor Vehicle Fuel.

SENATOR CLARK: This Amendment was put out by the Department of Revenue. They decided this had to be in there to be correct. So I would ask that this be returned to select file for this specific Amendment.

PRESIDENT: Any further discussion of the motion. Question is shall LB 397, be returned to select file for this specific Amendment as explained by Senator Clark? All those in favor of returning the Bill to select file for specific Amendment will vote aye, all those opposed will vote no. Motion is to return LB 397, to select file for specific Amendment. Thank-you, the clerk will record.

CLERK: 27 ayes, Mr. President and a motion to return.

PRESIDENT: The Bill is returned. Senator Clark, back to you.

SENATOR CLARK: I would move for the adoption of the Amendment.

PRESIDENT: Any further discussion now of the Amendment to 397, on select file? Any discussion? Question is, shall the Amendment be adopted. All those in favor, vote aye, all those opposed vote no. You are voting on the adoption of the specific Amendment to 397 on select file. Thank-you, clerk will record.

CLERK: 27 ayes, no nays on a motion to adopt.

PRESIDENT: The motion is adopted. Senator Clark.

SENATOR CLARK: I move the Bill be a, sent to E&R for engrossing.

PRESIDENT: Senator Duis, ok, the question is, shall LB 397 be readvanced as Amended. All those in favor please say aye. Those opposed say no. So ordered. The Bill is amended as advanced. Now. Senator Duis.

SENATOR DUIS: Mr. President, I just have an announcement to make here that might be of interest to someone. As you know we also have a, committee who is a regular committee of the Legislature on Administrative rules and regulations. I've just received word that regulations for Plattsmouth, Water Fowl management, area, resources regulations have been filed with us. Also regulations for Clear Creek, Waterfowl Management area, and Lake McConaughy, has just been filed with us and there are some change in rules and regulations in case any of you are interested.

PRESIDENT: Do we have any other business on the desk.

CLERK: Yes, Mr. President, I move to return LB 492 for select file for specific Amendments signed, Senator Whitney. The Amendment is to Amend on page 2, line 12, insert 1, after accepting. In line 16, insert 2, such part time employees who are members of the system.
