

PRESIDENT: Motion now is to adopt the amendments to LR8. All those in favor of adopting the amendments say aye, those opposed say no. So ordered. The amendments are adopted.

SENATOR CAVANAUGH: Mr. President, I move that LR8 as amended be advanced to E & R for engrossing.

PRESIDENT: Motion now is to advance LR8. All those in favor of advancing the bill please say aye, those opposed say no. So ordered. The bill as amended is advanced.

SENATOR CAVANAUGH: Mr. President, I move the adoption of the E & R amendments to LB377.

PRESIDENT: Motion is to adopt the amendments to LB377. All those in favor of adopting the amendments please say aye, those opposed say no. So ordered. The amendments are adopted.

SENATOR CAVANAUGH: Mr. President, I move that LB377 as amended be advanced to E & R for engrossing.

PRESIDENT: The motion is to advance LB377 as amended. All those in favor of advancing the bill as amended please say aye, those opposed say no. Bill as amended is advanced.

SENATOR CAVANAUGH: Mr. President I move that LB432 be advanced to E & R for engrossing.
