PRESIDENT: Any further discussion of the bill. Senator Murphy do you have any closing.

SENATOR MURPHY: Yes, Please.

PRESIDENT: The question is shall LB692 be advanced from General File to E & R Initial. All those in favor vote aye, and all those opposed vote no. You are voting on the advancement of LB692 on General File. Well, have you all voted? SENATOR Murphy, I didn't hear your motion, Sir. All right, Senator Murphy is asking for a Call of the House. Go ahead and record what you have. I'm sorry, Senator Nore asked for a record vote anyway. All right let's go back here. We'll try it this way, Senator Murphy has asked for a Call of the House. Do you support a Call of the House vote aye, if not vote no. SENATOR Murphy has asked for a call of the house. Wait a minute, let me clear the call here. Senator Nore has asked for a record vote, the problem was we cleared the board, so we are going to have to go back through this anyway. This motion is for a Call of the House. Do you support a Call of the House. That's the only issue before us at this particular time. All right, Clerk will record.

CLERK: 21 ayes, 8 nays, to go under Call.

PRESIDENT: We are under Call of the House. The next bell please indicate your presence. We are asking you to indicate your presence, we are under a Call of the House, Now Senator Clark for what purpose do you rise? Voting aye on the original issue. Stand by, because we had a malfunction and then we lost those who had voted before, so we are going to have to vote on the issue again. Stand by, just a minute. Senator Nore has asked for a record vote anyway. Please indicate your presence, we are under a Call of the House. Senator Murphy don't wonder off, we are under a Call of the House. All right, we are under a Call of the House, and we had a malfunction and we lost the original tally. The question under vote is, shall LB692 be advanced from General File to E & R Initial, that's the vote. We are going to try that again, and then we will see what develops from that point. Do you support the advancement of LB692 from General File vote aye, if not v ote no. This is a motion for the advancement of LB692 from General File to E 7 R Initial. Motion is to advance 692 from General File. Have you all voted? We are under a Call of lthe House and the motion under vote is shall LB692 be advanced from General File to E & R Initial. All right. Stand by. Stand by. Shall LB692 be advanced from General File to E & R Initial, that's the issue under vote. Have you all voted? Clerk will record. The motion is to raise the call. Just a minute.

CLERK: Voting aye, 25, voting nay 15, not voting 9.

PRESIDENT: Pardon me, we are still under Call of the House yes. Stand by for just a minute here. All right, LB692 advances from General File to E & R Initial. Senator Murphy's motion is to Raise a Call of the House. Now, Senator Marsh for what purpose do you rise.
