CHAPLAIN: Gave prayer.

PRESIDENT: Roll call. Record your presence, please. Have you indicated your presence, Senators? Record, Mr. Clerk.

CLERK: We do have a quorum present, Mr. President.

PRESIDENT: Corrections in the Journal.

CLERK: The Journal is without error, Mr. President.
