SENATOR MARVEL: Senator Dworak...yes, you're here. Senator Reutzel, is it alright to proceed with the roll call?

CLERK: (Took roll call vote found on page 961 of the Journal).
21 ayes, 17 nays.

SENATOR MARVEL: Motion lost. We're still under Call. Who moves the Call be raised? Is there a second? Okay. You want to clear the board, Mr. Clerk. The motion is to raise the Call. All those in favor vote aye, opposed vote no. Clerk record.

CLERK: 26 ayes, 0 nays to raise the Call.

SENATOR MARVEL: The Call is raised.

CLERK: Mr. President, may I read in some material for the Journal before we continue Select File. Mr. President, your Enrolling Clerk reports that she did present to the Governor for his approval, at 3:55 today, LB 88. Mr. President, notice of an Executive Session, Miscellaneous Subjects. Signed, Senator Don Dworak. Mr. President, your Committee on Revenue to whom was referred LB 140 instructs me to report the same be advanced to General File as amended, 276 General File, 436 General File...wait a minute. Mr. President, correction. Your Committee on Revenue refers LB 140 to General File. Signed, Senator Keyes. Committee on Judiciary refers LB 276 General File, 436 General File, 330 indefinitely postponed, 418 indefinitely postponed. Signed, Senator Barnett. Mr. President, your Committee on Education to whom was referred LB 430 instructs me to report the same to the Legislature with the recommendation it be advanced to General File, 488 indefinitely postponed. Signed, Senator Frank Lewis. Mr. President, your Committee on Retirement to whom was referred LB 345 instructs me to report the same to the Legislature with the recommendation it be advanced to General File, 467 General File, 466 indefinitely postponed. Signed, Senator Hasebroock, Chairman. Mr. President, your Committee on Committees gives notice of a report of a hearing on February 18th as well as March 18th. These will be set out in full in the Legislative Journal.

SENATOR MARVEL: Is that it, Mr. Clerk?

CLERK: No, no. Mr. President, Senator Barnett asks unanimous consent to print amendments to LB 21. Mr. President, Senator Brennan asks to print an amendment in the Journal to LB 38. Mr. President, Senator DeCamp asks to print amendments to LB 257 in the Legislative Journal.

SENATOR MARVEL: No objections. So ordered.

CLERK: Mr. President, Senator DeCamp also asks to print amendments in the Journal to 257.

SENATOR MARVEL: Are you through? Is that it, Mr. Clerk? He wants to adjourn, and I'm trying to hold the vote till you get....

CLERK: Mr. President, we have a Legislative Resolution, number 36 to be read. (Read LR 36 found on page 969 of the Journal).
