CLERK: Mr. President, read Standing Committee Report from Government, Military and Veterans Affairs on page 1251 of the Journal. LB 148 Indefinitely postponed. Mr. President, Senator Fowler asked unanimous consent to print amendments to LB 124. Mr. President, Legislative Resolution No. 48 introduced by Senator Nelson Merz will be read into the Journal and laid over. Read resolution on page 1252 of the Journal. Mr. President, Senator Marsh asked unanimous consent to print amendments to LB 201 in the Journal. (Refer to page 1252).

SENATOR F. LEWIS: Mr. Clerk, why don't we take on Select File the first 2 bills so that we can move them. That is LB 80 and LB 494.

CLERK: Mr. President, I have some more stuff to read in. Mr. President, a communication from the executive office under date of April 4, 1977. Read communication on page 1253 of the Journal. CLERK: Mr. President, read Reference Committee Report on page 1254 of the Journal. LB 528 to Miscellaneous Subjects Committee. Read notice of committee hearing from Miscellaneous Subjects on page 1254 of the Journal. Mr. President, a new bill, LB 390A introduced by the committee on Agriculture and Environment. Signed by Senator Schmit, Chairman. Read LB 390A. That's all Mr. President.

SENATOR F. LEWIS: Senator Nichol.

SENATOR NICHOL: Mr. Chairman, members of the Legislature. I move the E & R amendments to LB 80.

SENATOR F. LEWIS: You've heard the question. All in favor of adopting the E & R amendments say aye, those opposed say no. They are adopted. Senator Nichol.

SENATOR NICHOL: Mr. Chairman, members of the Legislature. I move that LB 80 be moved to E & R Engrossing.

SENATOR F. LEWIS: It's been moved by Senator Nichol to move LB 80 to E & R Final. All those in favor say aye, those opposed. Senator Savage.

SENATOR SAVAGE: Mr. President, I'd like to have the Committee on Committees excused for an important public hearing immediately.

SENATOR F. LEWIS: You've heard that announcement. Again, the motion was the advancement of LB 80. All those in favor say aye, those opposed nay. It's advanced. Senator Nichol; Cullan.
