(Speaker Luedtke presiding)

SPEAKER LUEDTKE: Record your presence. Record the presence.

CLERK: Mr. President, a quorum is present. Mr. President, LR 95 is ready for your signature.

SPEAKER LUEDTKE: The E & R amendments to LB 38. All those in favor of the E & R amendments to LB 38 say aye. Opposed nay. The E & R amendments are adopted.

SENATOR BARNETT: I'd move for the advancement of LB 38 as amended.

SPEAKER LUEDTKE: Motion to advance LB 38 to E & R for engrossment. All those... Any discussion? All those in favor say aye. Opposed nay. LB 38 is advanced to E & R for engrossment. LB 38A.

SENATOR BARNETT: I'd move for the E & R amendments to LB 38A.

SPEAKER LUEDTKE: Motion to adopt the E & R amendments to LB 38A. Any discussion? All those in favor say aye. Opposed nay. The E & R amendments are adopted to LB 38A. Senator Barnett.

SENATOR BARNETT: I'd move to advance LB 38A, as amended, to E & R engrossing.

SPEAKER LUEDTKE: Motion to advance LB 38A to E & R for engrossment. All those in favor say aye. Opposed nay. LB 38A is advanced to E & R for engrossment. LB 39.
