SPEAKER LUEDTKE: Motion fails. We're on Final Reading. Will the Sergeant at Arms make sure that all the legislators are back at their desks so that we can take up LB 346 on Final Reading. Some of the legislators have been excused. Some of the senators have been excused. Would all those who have been excused return to their desks, all nonlegislative personnel leave the floor, should be off the floor now because we're on Final Reading.

CLERK: Mr. President, Senator Kelly asked to be excused the 23, 24th and 25th, and June 1.

SPEAKER LUEDTKE: No objections, so ordered. Mr. Clerk, you may proceed then with the Final Reading of LB 346. Oh, that's right. We go to the next bill then.

CLERK: Read title to LB 542.

SPEAKER LUEDTKE: All provisions of law relative to procedure having been complied with, the question is, shall the bill pass. All those in favor vote aye, opposed nay. Have you all voted? Record the vote.

CLERK: Read record found on page 2150 of the Journal. 39 ayes, 5 nays, 5 not voting.

SPEAKER LUEDTKE: LB 542 passes. That will conclude Final Reading. In order to expedite the work of E & R, Senator Cullan, we're going to take up these various bills, to move them along before we go into this special order. So, Senator Cullan, LB 52.

SENATOR CULLAN: Mr. President, members of the Legislature. I move the E & R amendments to LB 52 be adopted.

SPEAKER LUEDTKE: Motion is to adopt the E & R amendments to LB 52. Any discussion? All those in favor vote aye. Opposed nay. The E & R amendments to LB 52 are adopted.

SENATOR CULLAN: Mr. President, members of the Legislature. I move that LB 52, as amended, be advanced to E & R for engrossment.

SPEAKER LUEDTKE: Motion is to advance LB 52 to E & R for engrossment. Any discussion? All those in favor vote aye. Opposed nay. LB 52 is advanced to E & R for engrossment. LB 509.

SENATOR CULLAN: Mr. President, members of the Legislature. I move the E & R amendments to LB 509 be adopted.

SPEAKER LUEDTKE: Motion is to adopt the E & R amendments to LB 509. Any discussion? All those in favor of adopting the E & R amendments to LB 509 vote aye. Opposed nay. The E & R amendments are adopted. Senator Cullan.

SENATOR CULLAN: Mr. President, members of the Legislature. I move that LB 509, as amended, be advanced to E & R for engrossment.

SPEAKER LUEDTKE: Motion is to advance 509 to E & R for engrossment. Any discussion? All those in favor vote aye. Opposed nay. LB 509 is advanced to E & R for engrossment. LB 530.
