SPEAKER LUEDTKE: Any further discussion on the Frank Lewis amendment to LB 501? If not, all those in favor of the Frank Lewis amendment vote aye, opposed nay. Have you all voted? Has everybody voted? Record the vote.

CLERK: 25 ayes, 0 nays on the adoption of the F. Lewis amendment, Mr. President.

SPEAKER LUEDTKE: The F. Lewis amendment is adopted. Any further amendments to LB 501?

CLERK: I have nothing further on the bill, Mr. President.

SPEAKER LUEDTKE: Senator Fowler, do you want to...or Senator Cullan, whichever one. Senator Cullan.

SENATOR CULLAN: Mr. President, members of the Legislature, I move that LB 501, as amended, be advanced to E & R for engrossment.

SPEAKER LUEDTKE: Motion to advance LB 501 to E & R for engrossment. Any discussion? All those in favor signify by saying aye. Opposed nay. LB 501 is advanced to E & R for engrossment. LB 660.

CLERK: LB 660. First of all, the E & R amendments have not been adopted.

SPEAKER LUEDTKE: Senator Cullan.

SENATOR CULLAN: Mr. President, members of the Legislature, I move the E & R amendments to LB 660 be adopted.

SPEAKER LUEDTKE: Motion is to adopt the E & R amendments to LB 660. Any discussion? All those in favor of adopting the E & R amendments to LB 660 signify by saying aye. Opposed nay. The E & R amendments to LB 660 are adopted. Mr. Clerk.

CLERK: Mr. President, I now have an amendment offered by Senator Maxey and Senator Marvel. The amendment can be found on page 518 of the Legislative Journal.

SPEAKER LUEDTKE: Who is going to.... Senator Marvel or Senator Maxey going to handle this? Senator Marvel. Chair recognizes Senator Marvel.

SENATOR MARVEL: I have three amendments. This is the first of the three. It's found on the bottom of 518 and the top of 518. Basically, what it does is separate cars and trucks from trailer houses and allow, which is not in the books now as near as I understand in talking with a number of these people, to allow for an appeal from valuations like other people have. That, basically, is what the.... There is no appeal at the moment when the owners of mobile homes are notified of a change. In this case there has been a massive change this particular year. I move for the adoption of that amendment.
