Mr. President, Senator Keyes would like to be excused until he arrives. Mr. President, Senator Frank Lewis would like to be excused until he arrives.

CLERK: A quorum present, Mr. President.

PRESIDENT: Corrections for the Journal.

CLERK: I have none, Mr. President.
