LB 576, 700, 808,
889 A, 922, 210

SENATOR MARVEL: The motion is carried and the amendment is adopted. Senator Koch.

SENATOR KOCH: Mr. President, I move that LB 889 A be advanced to E & R Final and be expedited.

SENATOR MARVEL: You've heard the motion. Is there a second? All those in favor say aye. Opposed no. The motion is carried and the bill, 889, is advanced to E & R for Engrossment with orders to expedite. That concludes item number seven. We will not go to item number eight which will continue until noon recess. Before we do that in the south balcony from Senator Carsten's district, nine students and three adults, sponsors, from the Nebraska School for the Visually Handicapped. Would you hold up your hands so we can welcome you?

CLERK: Mr. President, your Committee on Enrollment and Review respectfully reports that we have carefully examined and reviewed LB 576 and recommend that same be replaced on Select File, 700 replaced on Select File. Mr. President, Senator Maresh asks unanimous consent to print some material in the Legislative Journal. (See page 1785 of the Journal.) Mr. President, Senator Venditte asks unanimous consent to print amendments to LB 808, Senator Kremer to LB 922. Mr. President, a new resolution, LR 230 offered by Senator Chambers. (Read LR 230 as found on pages 1785 and 1786 of the Journal.) That will be referred to the Executive Board, Mr. President.

CLERK: Mr. President, LB 210 was--the E & R amendments were adopted by the body on March 13th. It failed to advance at that time. Yesterday there were amendments offered and adopted by Senator Dworak, further amendments offered by Senator Kelly and DeCamp were adopted. Senator Koch made a motion to indefinitely postpone LB 210 and that is pending, Mr. President.

SENATOR MARVEL: Senator Koch, do you wish to be recognized?

SENATOR KOCH: Mr. President, in the interest of good spirit and comradeship I'll withdraw that momentarily.

SENATOR MARVEL: Senator Cullan.

SENATOR CULLAN: Mr. President, members of the Legislature I move that LB 210 as amended be advanced to E & R for Engrossment.

SENATOR MARVEL: The motion is to advance 210 to E & R for Engrossment. Machine vote is requested. Is that the motion to advance the bill? Okay. All those in favor of advancing 210 to E & R for Engrossment vote aye. Opposed vote no. I'll vote aye, Mr. Clerk.

CLERK: Senator Marvel voting aye.

SENATOR MARVEL: Have you all voted? The motion is to advance the bill. Record vote has been requested. Have you all voted? The question is shall the House go under Call. Will you clear the board, Mr. Clerk? All those in favor of the House going under Call vote aye. Opposed vote no. Record.
