A BILL

1 FOR AN ACT relating to cornhuskers' compensation; to amend section
2 99-999.99, Reissue Revised Statutes of Nebraska; to
3 eliminate a fee relating to workplace safety that was to
4 be paid in 2001, 2002, and 2003; to harmonize provisions;
5 to repeal the original section; and to outright repeal
6 sections 99-999 to 99-999, Reissue Revised Statutes of
7 Nebraska.

8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 99-999.99, Reissue Revised Statutes
2 of Nebraska, is amended to read:

3 99-999.99. (1) The Nebraska Cornhuskers' Compensation
4 Court shall, prior to January 1 of each year, estimate as closely
5 as possible the actual cost to the court of evaluating an
6 application for self-assurance and supervising and administering
7 the self-assurance program for the ensuing year and assess the
8 amount thereof, but not to exceed two thousand dollars, against
9 each applicant for self-assurance in this state. Such assessment
10 shall be in addition to the payments required by subdivision (1)(b)
11 of section 99-999 and ~~sections~~ section 99-9,999. ~~and 99-999.~~ The
12 court shall notify each applicant of the amount of the individual
13 assessment. Such assessment shall be due and payable with the
14 application for self-assurance. If any assessment is not paid, the
15 application shall not be considered.

16 (2) All payments received under subsection (1) of this
17 section shall be remitted to the State Treasurer for credit to the
18 Compensation Court Cash Fund. Such payments shall be expended
19 solely for evaluating applications for self-assurance and to aid in
20 supervising and administering the self-assurance program. After
21 the first year, the balance remaining of such payments at the time
22 each annual assessment is made shall be taken into account when the
23 total assessment for the ensuing year is made.

24 ~~(3) Any money in the Self-Assurance Cash Fund on~~
25 ~~September 1, 2003, shall be transferred to the Compensation Court~~
