A BILL

1 FOR AN ACT relating to appropriations; to appropriate funds to aid
2 in carrying out the provisions of Legislative Bill 329,
3 Ninety-seventh Legislature, First Session, 2001; and to
4 declare an emergency.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$250,000
2 from the General Fund for FY2001-02 and (2) \$250,000 from the
3 General Fund for FY2002-03 to the Department of Natural Resources,
4 for Program 309, to aid in carrying out the provisions of
5 Legislative Bill 329, Ninety-seventh Legislature, First Session,
6 2001.

7 There is included in the appropriation to this program
8 for FY2001-02 \$250,000 General Funds for state aid, which shall
9 only be used for such purpose. There is included in the
10 appropriation to this program for FY2002-03 \$250,000 General Funds
11 for state aid, which shall only be used for such purpose.

12 No expenditures for permanent and temporary salaries and
13 per diems for state employees shall be made from funds appropriated
14 in this section.

15 Sec. 2. There is hereby appropriated (1) \$1,250,000 from
16 the Natural Resources Water Quality Fund for FY2001-02 and (2)
17 \$1,250,000 from the Natural Resources Water Quality Fund for
18 FY2002-03 to the Department of Natural Resources, for Program 309,
19 to aid in carrying out the provisions of Legislative Bill 329,
20 Ninety-seventh Legislature, First Session, 2001.

21 There is included in the appropriation to this program
22 for FY2001-02 \$1,250,000 Cash Funds for state aid, which shall only
23 be used for such purpose. There is included in the appropriation
24 to this program for FY2002-03 \$1,250,000 Cash Funds for state aid,
25 which shall only be used for such purpose.

26 No expenditures for permanent and temporary salaries and
27 per diems for state employees shall be made from funds appropriated
28 in this section.

1 Sec. 3. There is hereby appropriated (1) \$50,000 from
2 the General Fund for FY2001-02 and (2) \$50,000 from the General
3 Fund for FY2002-03 to the Department of Environmental Quality, for
4 Program 513, to aid in carrying out the provisions of Legislative
5 Bill 329, Ninety-seventh Legislature, First Session, 2001.

6 No expenditures for permanent and temporary salaries and
7 per diems for state employees shall be made from funds appropriated
8 in this section.

9 Sec. 4. There is hereby appropriated (1) \$300,000 from
10 the Fertilizers and Soil Conditioners Administrative Fund for
11 FY2001-02 and (2) \$-0- from the Fertilizers and Soil Conditioners
12 Administrative Fund for FY2002-03 to the Department of Agriculture,
13 for Program 333, to aid in carrying out the provisions of
14 Legislative Bill 329, Ninety-seventh Legislature, First Session,
15 2001.

16 No expenditures for permanent and temporary salaries and
17 per diems for state employees shall be made from funds appropriated
18 in this section.

19 Sec. 5. Since an emergency exists, this act takes effect
20 when passed and approved according to law.
