A BILL

- 1 FOR AN ACT relating to appropriations; to appropriate funds to aid
- 2 in carrying out the provisions of Legislative Bill 1199,
- 3 Ninety-ninth Legislature, Second Session, 2006.
- 4 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$703,910 from
2 the General Fund for FY2006-07 and (2) \$892,448 from the General
3 Fund for FY2007-08 to the Department of Correctional Services, for
4 Program 200, to aid in carrying out the provisions of Legislative
5 Bill 1199, Ninety-ninth Legislature, Second Session, 2006.

6 Total expenditures for permanent and temporary salaries
7 and per diems from funds appropriated in this section shall not
8 exceed \$305,786 for FY2006-07 or \$421,757 for FY2007-08.

9 Sec. 2. There is hereby appropriated (1) \$1,815,000
10 from the General Fund for FY2006-07 and (2) \$6,352,500 from the
11 General Fund for FY2007-08 to the Department of Health and Human
12 Services, for Program 870, to aid in carrying out the provisions
13 of Legislative Bill 1199, Ninety-ninth Legislature, Second Session,
14 2006.

15 Total expenditures for permanent and temporary salaries
16 and per diems from funds appropriated in this section shall not
17 exceed \$1,100,000 for FY2006-07 or \$3,800,000 for FY2007-08.

18 Sec. 3. There is hereby appropriated \$3,666,000 from the
19 General Fund for FY2006-07 to the Department of Health and Human
20 Services, for Program 870, to aid in carrying out the provisions
21 of Legislative Bill 1199, Ninety-ninth Legislature, Second Session,
22 2006.

23 Total expenditures for permanent and temporary salaries
24 and per diems from funds appropriated in this section shall not
25 exceed \$2,240,000 for FY2006-07.

1 Sec. 4. There is hereby appropriated \$12,168 from the
2 General Fund for FY2006-07 to the Department of Health and Human
3 Services Regulation and Licensure, for Program 177, to aid in
4 carrying out the provisions of Legislative Bill 1199, Ninety-ninth
5 Legislature, Second Session, 2006.

6 No expenditures for permanent and temporary salaries and
7 per diems for state employees shall be made from funds appropriated
8 in this section.
