A BILL

1 FOR AN ACT relating to appropriations; to appropriate funds to aid  
2 in carrying out the provisions of Legislative Bill 746,  
3 Ninety-ninth Legislature, Second Session, 2006; and to  
4 reduce appropriations.  
5 Be it enacted by the people of the State of Nebraska,

1           Section 1. There is hereby appropriated (1) \$200,000 from  
2 the General Fund for FY2006-07 and (2) \$200,000 from the General  
3 Fund for FY2007-08 to the Supreme Court, for Program 52, to aid in  
4 carrying out the provisions of Legislative Bill 746, Ninety-ninth  
5 Legislature, Second Session, 2006.

6           There is included in the appropriation to this program  
7 for FY2006-07 \$200,000 General Funds for state aid, which  
8 shall only be used for such purpose. There is included in the  
9 appropriation to this program for FY2007-08 \$200,000 General Funds  
10 for state aid, which shall only be used for such purpose.

11           No expenditures for permanent and temporary salaries and  
12 per diems for state employees shall be made from funds appropriated  
13 in this section.

14           Sec. 2. There is hereby appropriated (1) \$145,000 from  
15 the Civil Legal Services Fund for FY2006-07 and (2) \$290,000  
16 from the Civil Legal Services Fund for FY2007-08 to the Supreme  
17 Court, for Program 52, to aid in carrying out the provisions of  
18 Legislative Bill 746, Ninety-ninth Legislature, Second Session,  
19 2006.

20           No expenditures for permanent and temporary salaries and  
21 per diems for state employees shall be made from funds appropriated  
22 in this section.

23           There is included in the appropriation to this program  
24 for FY2006-07 \$145,000 Cash Funds for state aid, which shall only  
25 be used for such purpose. There is included in the appropriation to

1 this program for FY2007-08 \$290,000 Cash Funds for state aid, which  
2 shall only be used for such purpose.

3           Sec. 3. There is hereby appropriated (1) \$63,500 from  
4 the General Fund for FY2006-07 and (2) \$127,000 from the General  
5 Fund for FY2007-08 to the Nebraska Commission on Law Enforcement  
6 and Criminal Justice, for Program 199, to aid in carrying out  
7 the provisions of Legislative Bill 746, Ninety-ninth Legislature,  
8 Second Session, 2006.

9           No expenditures for permanent and temporary salaries and  
10 per diems for state employees shall be made from funds appropriated  
11 in this section.

12           Sec. 4. The Cash Fund appropriation for FY2006-07 for  
13 the Nebraska Commission on Law Enforcement and Criminal Justice,  
14 for Program 199, is hereby reduced by \$63,500. The Cash Fund  
15 appropriation for FY2007-08 for the Nebraska Commission on Law  
16 Enforcement and Criminal Justice, for Program 199, is hereby  
17 reduced by \$127,000.
