A BILL

1 FOR AN ACT relating to appropriations; to appropriate funds to aid
2 in carrying out the provisions of Legislative Bill 90,
3 Ninety-ninth Legislature, First Session, 2005; and to
4 declare an emergency.
5 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$150,000
2 from the General Fund for FY2005-06 and (2) \$150,000 from the
3 General Fund for FY2006-07 to the Department of Economic
4 Development, for Program 134, to aid in carrying out the provisions
5 of Legislative Bill 90, Ninety-ninth Legislature, First Session,
6 2005.

7 Total expenditures for permanent and temporary salaries
8 and per diems from funds appropriated in this section shall not
9 exceed \$105,517 for FY2005-06 or \$105,517 for FY2006-07.

10 Sec. 2. There is hereby appropriated (1) \$850,000 from
11 the General Fund for FY2005-06 and (2) \$850,000 from the General
12 Fund for FY2006-07 to the Department of Economic Development, for
13 Program 601, to aid in carrying out the provisions of Legislative
14 Bill 90, Ninety-ninth Legislature, First Session, 2005.

15 No expenditures for permanent and temporary salaries and
16 per diems for state employees shall be made from funds appropriated
17 in this section.

18 There is included in the appropriation to this program
19 for FY2005-06 \$850,000 General Funds for state aid, which shall
20 only be used for such purpose. There is included in the
21 appropriation to this program for FY2006-07 \$850,000 General Funds
22 for state aid, which shall only be used for such purpose.

23 Sec. 3. There is hereby appropriated (1) \$250,000 from
24 the General Fund for FY2005-06 and (2) \$250,000 from the General
25 Fund for FY2006-07 to the Department of Economic Development, for
26 Program 603, to aid in carrying out the provisions of Legislative
27 Bill 90, Ninety-ninth Legislature, First Session, 2005.

28 No expenditures for permanent and temporary salaries and

1 per diems for state employees shall be made from funds appropriated
2 in this section.

3 There is included in the appropriation to this program
4 for FY2005-06 \$250,000 General Funds for state aid, which shall
5 only be used for such purpose. There is included in the
6 appropriation to this program for FY2006-07 \$250,000 General Funds
7 for state aid, which shall only be used for such purpose.

8 Sec. 4. The State Treasurer shall transfer \$2,500,000
9 from the General Fund to the Ethanol Production Incentive Cash Fund
10 on or before June 30, 2006, or on such date as directed by the
11 budget administrator. The State Treasurer shall transfer
12 \$2,500,000 from the General Fund to the Ethanol Production
13 Incentive Cash Fund on or before June 30, 2007, or on such date as
14 directed by the budget administrator.

15 Sec. 5. Since an emergency exists, this act takes effect
16 when passed and approved according to law.
