

LEGISLATIVE BILL 503A

Approved by the Governor April 27, 2005

Introduced by Stuhr, 24

AN ACT relating to appropriations; to appropriate funds to aid in carrying out the provisions of Legislative Bill 503, Ninety-ninth Legislature, First Session, 2005; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

Section 1. There is hereby appropriated (1) \$116,862 from the Nebraska Public Employees Retirement Systems Expense Fund for FY2005-06 and (2) \$40,767 from the Nebraska Public Employees Retirement Systems Expense Fund for FY2006-07 to the Public Employees Retirement Board, for Program 41, to aid in carrying out the provisions of Legislative Bill 503, Ninety-ninth Legislature, First Session, 2005.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$29,694 for FY2005-06 or \$30,660 for FY2006-07.

Sec. 2. There is hereby appropriated (1) \$4,800 from the Nebraska Public Employees Retirement Systems Expense Fund for FY2005-06 and (2) \$4,800 from the Nebraska Public Employees Retirement Systems Expense Fund for FY2006-07 to the Public Employees Retirement Board, for Program 42, to aid in carrying out the provisions of Legislative Bill 503, Ninety-ninth Legislature, First Session, 2005.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$4,800 for FY2005-06 or \$4,800 for FY2006-07.

Sec. 3. There is hereby appropriated (1) \$804,161 from the General Fund for FY2005-06 and (2) \$864,332 from the General Fund for FY2006-07 to the Nebraska State Patrol, for Program 100, to aid in carrying out the provisions of Legislative Bill 503, Ninety-ninth Legislature, First Session, 2005.

No expenditures for permanent and temporary salaries and per diems for state employees shall be made from funds appropriated in this section.

Sec. 4. There is hereby appropriated (1) \$164,654 from the Carrier Enforcement Cash Fund for FY2005-06 and (2) \$176,423 from the Carrier Enforcement Cash Fund for FY2006-07 to the Nebraska State Patrol, for Program 205, to aid in carrying out the provisions of Legislative Bill 503, Ninety-ninth Legislature, First Session, 2005.

No expenditures for permanent and temporary salaries and per diems for state employees shall be made from funds appropriated in this section.

Sec. 5. There is hereby appropriated (1) \$2,664 from the State Investment Officer's Cash Fund for FY2005-06 and (2) \$2,664 from the State Investment Officer's Cash Fund for FY2006-07 to the Nebraska Investment Council, for Program 610, to aid in carrying out the provisions of Legislative Bill 503, Ninety-ninth Legislature, First Session, 2005.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$2,664 for FY2005-06 or \$2,664 for FY2006-07.

Sec. 6. Since an emergency exists, this act takes effect when passed and approved according to law.
