- 2 Retention Act; to amend section 85-2602, Revised Statutes
- 3 Supplement, 2023; to redefine terms; and to repeal the original

- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 85-2602, Revised Statutes Supplement, 2023, is

- 2 amended to read:
- 3 85-2602 For purposes of the First Responder Recruitment and
- 4 Retention Act:
- 5 (1) Associate degree program means a degree program at a community
- 6 college, state college, or state university which typically requires
- 7 completion of an organized program of study of at least sixty semester
- 8 credit hours or an equivalent that can be shown to accomplish the same
- 9 goal. Associate degree program does not include a baccalaureate degree
- 10 program;
- 11 (2) Baccalaureate degree program means a degree program at a
- 12 community college, state college, or state university which typically
- 13 requires completion of an organized program of study of at least one
- 14 hundred twenty semester credit hours or an equivalent that can be shown
- 15 to accomplish the same goal;
- 16 (3) Community college means a public postsecondary educational
- 17 institution which is part of the community college system and includes
- 18 all branches and campuses of such institution located within the State of
- 19 Nebraska;
- 20 (4) Law enforcement officer means any person who is responsible for
- 21 the prevention or detection of crime or the enforcement of the penal,
- 22 game, traffic, or highway laws of the State of Nebraska or any political
- 23 subdivision of the state for more than one hundred hours per year and who
- 24 is authorized by law to make arrests. Law enforcement officer includes a
- 25 conservation officer of the Game and Parks Commission;
- 26 (5) Law enforcement agency means a police department in a
- 27 municipality, a sheriff's office,—and the Nebraska State Patrol, and the
- 28 Game and Parks Commission;
- 29 (6) Professional firefighter means a firefighter or firefighter-
- 30 paramedic who is a member of a paid fire department of a municipality or
- 31 a rural or suburban fire protection district in this state, including a

- 1 municipality having a home rule charter or a municipal authority created
- 2 pursuant to a home rule charter that has its own paid fire department,
- 3 and for whom firefighting is a full-time career;
- 4 (7) State college means a public postsecondary educational
- 5 institution which is part of the Nebraska state college system and
- 6 includes all branches and campuses of such institution located within the
- 7 State of Nebraska;
- 8 (8) State university means a public postsecondary educational
- 9 institution which is part of the University of Nebraska and includes all
- 10 branches and campuses of such institution located within the State of
- 11 Nebraska; and
- 12 (9) Tuition means the charges and cost of tuition as set by the
- 13 governing body of a state university, state college, or community
- 14 college.
