LB 801 amends current law to reflect the requirements of section 23-186 providing that the county treasurer is to be the county official who issues motor vehicle titles, registrations, license plates, renewal decals, notations of liens and collects taxes and fees for motor vehicles, all-terrain and utility type vehicles, minibikes, snowmobiles, trailers and motorboats. Current law requires the treasurer to be the county official responsible for such activities no later than January 1, 2011. The bill has no fiscal impact because it eliminates obsolete references to other county officials carrying out these responsibilities.
