This bill would require a facility that performs five or more abortions during any one calendar month or any facility that performs second or third trimester abortions to be licensed as an ambulatory surgical center.

There are three licensed health clinics that perform abortions that would meet the requirements for an ambulatory surgical center. There would be a small increase in fees and the additional work can be handled within existing resources. It is not known if there are physician offices that would meet the requirements contained in this bill. Explanation of Estimate:

This bill would revise the Health Care Facility Licensure Act for health clinics and ambulatory surgical centers so that any office or facility that performs five or more abortions in any month and/or a facility that performs second or third trimester abortions would need to be licensed as a health clinic and would need to meet the requirements as an ambulatory surgical center.

There are three current licensed health clinics that perform abortions which may meet the requirements for an ambulatory surgical center. To license the three health clinics would have minimal fiscal impact on the Licensure Unit. The Department would gain a minimal increase in fees, and staff resources are adequate to handle this work.

It is unknown, if there are a large number of physician offices where five or more abortions are performed on a monthly basis and/or where second or third trimester abortions are performed, this could have a much larger impact on the Licensure Unit and could potentially add the need for more staff to handle the increase in administration as well as survey activities.
