LB 70 provides some discretion in terms of the revocation of motor vehicle operator's licenses by courts when a person operates a vehicle during the time a license has been revoked or impounded. The bill provides that if a person is placed on probation for operating a motor vehicle when an operator's license is revoked, then the court has discretion as to whether a license is to be revoked. It is possible the change in the law make have some impact on the number of operator's licenses revoked in the future which will impact revenue received by the Department of Motor Vehicles. The change in license revocations is unknown, but not projected to be significant.
