Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 222 would change the membership of the Nebraska Tourism Commission and would amend sections of law governing the duties of the Commission and the programs administered by the agency.

Because the number of Commissioners would increase from 9 to 11 members, and the membership would have a greater geographic diversity, there would be increased travel reimbursement costs for Commissioners to attend meetings. There is no basis to disagree with the agency estimate of an additional \$10,000 in cash fund expenses. The costs could be absorbed by the existing cash fund spending authority of the agency.

LB 222 also expands a section of law governing grants provided by the Tourism Commission. It is estimated that the existing state aid spending authority is sufficient to allow for the development of additional grant categories.
