This bill would prohibit obstruction of a public power district employee, and the penalty is a Class I misdemeanor (Maximum — not more than one year imprisonment, or one thousand dollars fine, or both; Minimum — none).

The Supreme Court estimates no fiscal impact from this bill.

This bill could impact county jails. Misdemeanor sentences are generally served in county jails if jail time is imposed. This could result in additional costs to counties.

The Lancaster County Sheriff's Office estimates no fiscal impact from this bill.

Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools.
