LB 926 allows the Commissioner of Labor to issue a citation when an investigation reveals that a contractor has violated the Employee Classification Act. The administrative penalty for such violations shall not exceed five hundred dollars (\$500). Current statute provides for a five hundred dollar fine. The new language in LB 926 may result in a slight decrease in fine related revenue, but since the language is permissive, that cannot be accurately determined.
