LB191 would change the definitions of electors for an irrigation district or proposed irrigation district. The definition of elector is expanded to, "For any irrigation district or proposed irrigation district which borders another state and comprises less than two thousand acres and in which one-half or more of the landowners, leaseholders, or entrymen of government lands are not residents of the State of Nebraska, any person who:

- (A) Owns not less than fifteen acres of land within any such district;
- (B) Is an entryman of government land within any such district; or
- C) Holds a leasehold estate in not less than forty acres of state land within any such district for a period of not less than five years from the date at which such elector seeks to exercise the elective franchise"

The Department of Natural Resources estimates no fiscal impact upon their agency. Any impact would be related to irrigation districts, which would not see any fiscal impact as a result of this legislation. No fiscal impact to the General Fund.
