LB 514 provides for new deadlines for filing petitions with the Secretary of State. For primary elections, the new date is January 15, prior to the primary. For general elections, the new date is July 15 prior to the general election.

In addition, LB 514 requires the sponsor or sponsors to file all petition papers comprising a new political party for signature verification with the Secretary of State. All signed petitions in circulation but not filed with the Secretary of State shall become invalid after July 15 in the year of a statewide general election.
