LB 1247 would provide for recognition of tribal mental health and dangerous sex offender commitment orders as prescribed; to provide for tribal law enforcement officers to take a subject into emergency protective custody; and to provide for transportation of and commitment of persons committed under tribal law and for payment of related costs.

The proposed legislation would have no fiscal impact as the costs for emergency protective custody and transportation of a tribal member who is committed to a treatment facility is reimbursed by the tribal authority.

LB 1247 would provide for recognition of tribal mental health and dangerous sex offender commitment orders and for transportation of and commitment of persons civilly committed under tribal law. The fiscal impact to counties should be minimal or negligible because if emergency protective custody is initiated, the tribe is to pay the costs of the emergency protective custody and transportation costs by a sheriff for conveying a subject to a treatment facility are to be reimbursed by the tribe.
