LB 316 changes the application for marriage and the license and certificate for marriage.

LB 316 would require a one-time fee to change the VR Electronic Registration System by a Program Developer, at \$75.00 per hour for 8 hours. It would also require 8 hours of testing by a Senior Help Desk Coordinator at \$23.35 per hour. The total cost of this change is estimated to be \$786.80 and will be paid out of the Vital Records Cash Fund.
