LB 482 would adopt the Suicide Risk Protection Order Act. The suicide risk protection order will be filed with the clerk of the district court of the county where the respondent resides. Proceedings can be heard by the county or district court.

The suicide risk protection order will allege that the respondent poses a significant risk of causing personal injury to self or others by having in the respondent's custody or control, purchasing, possessing, or receiving a firearm.

Expenditures:

LB 482 creates a new type of protection order for the Supreme Court. The new protection order will require the agency to establish a new process and reporting mechanism. The agency will need to educate Judicial and court staff, and make modifications to the court case management system (JUSTICE). The estimated fiscal impact will be \$150,000. There is no basis to disagree with this estimate.

There is potentially a fiscal impact to counties but the amount is unknown as of right now.
