LB690 amends several sections to change provisions relating to the powers & duties of the Nebraska Department of Education (NDE).

In all sections of law, references to the State Department of Education (NDE) will be construed as directive to the Commissioner of Education unless specifically directing the State Board of Education in a duty or responsibility.

The commissioner will act under the authority of the statutes directing the State Board of Education & in matters specified to be directed by the State Board of Education as directed by the Legislature. In no circumstance will the State Board of Education assume authority over or direct the Commissioner of Education contrary to state law.

The Nebraska State Board of Education will report annually to the Education Committee of the Legislature on matters related to general supervision & administration of the state school system, provide an annual state of the schools report each January to the Legislature in a manner determined by the Speaker of the Legislature, present a biennial budget to the Appropriations Committee of the Legislature, act as the executive & administrative head of NDE, & report on the conduct of the State Board of Education to the Governor, Legislature, & Attorney General.
