**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

This bill adopts the Dentist and Dental Hygienist Compact for a licensing pathway to create reciprocity among participant states. Additional work would be required by the Department of Health and Human Services (DHHS) within Program 178 – Professional Licensure however the costs would be recouped through newly assessed fees. Minimal fiscal impact to DHHS.

Applicants under the Compact, dentists and dental hygienists from other states, would be subject to criminal background check by Nebraska State Patrol. The current rate for a criminal background check by fingerprinting is \$45.25. If required, the fee would be paid by the applicant. There is no fiscal impact to NSP.

**Explanation of Estimate:**

LB824 adopts the Dentist and Dental Hygienist Licensure Compact and changes provisions relating to criminal background checks. As of July 1, 2023, Nebraska had 1,617 licensed Dentists and 1,507 licensed Dental Hygienists. The Department of Health and Human Services (DHHS) would be responsible for issuing multi-state licenses for Nebraska home state Dentists and Dental Assistants only when requested by applicant. DHHS would be responsible for keeping track of out of state Dentists and Dental Hygienists practicing in Nebraska under compact privileges issued in another member state.

Additional work includes updates to rules and regulations; modifications to the licensure software system; creating data sets for information exchanges; application form changes; DHHS website information changes and providing a delegate employee to serve on the Dentist and Dental Hygienist Licensure Compact Commission.

All costs associated with implementing and administering multi-state licenses for Dentists and Dental Hygienists and participating in the Dentist and Dental Hygienist Licensure Compact Commission will be recovered under the Uniform Credentialing Act Sections 38-151 through 38-156 administrative costs and fees. Additional costs incurred to provide criminal background checks would also be passed along to the applicants.
