Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill states legislative intent to appropriate \$900,000 in FY24 and \$900,000 in FY25 from the General Fund to Program 514 Health Aid in the Department of Health and Human Services (DHHS) for evidence-based early intervention nurse home visitation programs. This increased appropriation would make Nebraska eligible for newly authorized matching funds for Maternal, Infant, and Early Childhood Home Visiting (MIECHV), a federally funded program in Federal Fiscal Year 2024, 2025, and 2026.

The Department of Health and Human Services indicates needing a new Federal Aid Administrator II starting in October 2024. It is not apparent that the workload associated with securing the new MIECHV matching grant is sufficient to justify a new position. It is reasonable to assume increased workload of 40 to 80 work hours per year which can be absorbed within the current appropriation of Program 33, Administration.

Explanation of Estimate:

If an associated "A" Bill for LB 1124 is passed to appropriate the funds, \$900,000 would be added to the existing General Fund appropriation to Program 514 - Health Aid for the current fiscal year and \$900,000 would be added to the General Fund appropriation to Program 514 - Health Aid for FY2024-2025.

The appropriation would be used to support the existing evidence-based early intervention home visiting program. There is a potential to claim an additional 300% in Federal matching funds for the Maternal, Infant, and Early Childhood Home Visiting (MIECHV) Program for each additional State dollar spent. The amount would be subject to Federal funding availability and state-specific ceiling limits.

Should the Department of Health and Human Services (DHHS) be appropriated these additional General Funds that can be used to seek new Federal matching funds, DHHS would require an additional 1.0 FTE Federal Aid Administrator II to be funded under Program 033 – Administration.
