LB 846 introduces the Bed Bug Detection and Treatment Act, detailing the responsibilities and procedures for tenants and landlords in managing bed bug infestations. This bill specifies tenant duties in reporting suspicions of bed bugs, outlines landlord responsibilities for inspection and treatment, establishes protocols for unit entry during inspections, prohibits renting units with known infestations, and defines legal consequences for non-compliance. The bill directs both parties participate in addressing and preventing bed bug issues in rental properties. There is no fiscal impact to the state.

There could be cost to counties but the amount is unknown.
