LB1233 would amend §72-819 to compel the Nebraska Game and Parks Commission (NGPC) to consult with the Ponca Tribe of Nebraska on the Chief Standing Bear Museum and Visitor Center development, exhibit fabrication, and historical interpretation. This bill creates the intent for the Legislature to appropriate \$750,000 in FY2023-24, from interest earnings from the Perkins County Canal Project Fund credited to the Economic Recovery Contingency Fund, for exhibit fabrication and historical interpretation. This would be in lieu of the previously established intended appropriation of \$750,000 in FY2025-26, which was established in LB531 (2023). This bill contains an emergency clause.

Note: this transfer from one cash fund to another cash fund, and corresponding appropriation occur in the current fiscal year (FY2023-24). The table above does not show these columns, however, an appropriation to allow NGPC to make these expenditures would be required.
