Re: Overdue Regulations Report

#### Overview

Under the Nebraska Administrative Procedure Act (APA), if the Legislature passes a bill requiring an administrative agency to promulgate regulations the agency must promulgate the regulation within two years of the bill going into effect. Agencies are required to report the status of these regulations to the Legislative Audit Office (LAO) by July 1 each year. Additionally, if mandatory regulations are not promulgated within three years of a bill's effective date, the law requires the relevant legislative standing committee to hold a public hearing.

### 2021 Report

We received reports from 66 agencies. Three agencies, the Attorney General, the Nebraska Brand Committee, and the Dairy Industry Development Board, did not submit a report as required by law.

Of those agencies who did report, only three reported regulations that may be overdue. The Department of Correctional Services, the Department of Education, and the Public Service Commission all reported regulations required by bills passed in 2019 or earlier that have not been promulgated. Those reports are attached to this memo. As per LAO practice, the reports were forwarded to Committee Counsels and Committee chairpersons of the relevant standing committees. We did not verify whether the regulations were in fact mandatory or overdue.
