1	FOR AN ACT relating to the Game Law; to amend sections 37-448
2	37-451, 37-458, 37-462, 37-463, 37-465, 37-478, 37-479
3	37-483, 37-484, 37-497, 37-4,104, 37-4,105, 37-4,106
4	and 37-4,108, Reissue Revised Statutes of Nebraska
5	sections 37-415 and 37-438, Revised Statutes Cumulative
6	Supplement, 2006, and section 37-426, Revised Statutes
7	Supplement, 2007; to remove certain statutory minimum
8	fees; and to repeal the original sections.
9	Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 37-415, Revised Statutes Cumulative

- 2 Supplement, 2006, is amended to read:
- 3 37-415 (1) The commission may issue to any Nebraska
- 4 resident a lifetime fishing, hunting, or combination hunting and
- 5 fishing permit upon application and payment of the appropriate fee.
- 6 The fee for a resident lifetime hunting permit shall be not less
- 7 than one hundred twenty-five dollars and not more than two hundred
- 8 ninety-nine dollars, the fee for a resident lifetime fishing permit
- 9 shall be not less than one hundred seventy-five dollars and not
- 10 more than three hundred forty-five dollars plus the cost of a
- 11 lifetime aquatic habitat stamp, and the fee for a resident lifetime
- 12 combination hunting and fishing permit shall be not less than
- 13 two hundred seventy-five dollars and not more than five hundred
- 14 ninety-eight dollars plus the cost of a lifetime aquatic habitat
- 15 stamp, as such fees are established by the commission pursuant to
- 16 section 37-327. Payment of the fee shall be made in a lump sum at
- 17 the time of application.
- 18 (2) A resident lifetime permit shall not be made invalid
- 19 by reason of the holder subsequently residing outside the state.
- 20 (3) The commission may issue to any nonresident a
- 21 lifetime fishing, hunting, or combination hunting and fishing
- 22 permit upon application and payment of the appropriate fee. The fee
- 23 for a nonresident lifetime hunting permit shall be not less than
- 24 six hundred twenty-five dollars and not more than twelve hundred
- 25 fifty dollars, the fee for a nonresident lifetime fishing permit

1 shall be not less than four hundred fifty dollars and not more than

- 2 eight hundred fifty dollars plus the cost of a lifetime aquatic
- 3 habitat stamp, and the fee for a nonresident lifetime combination
- 4 hunting and fishing permit shall be not less than nine hundred
- 5 seventy-five dollars and not more than two thousand dollars plus
- 6 the cost of a lifetime aquatic habitat stamp, as such fees are
- 7 established by the commission pursuant to section 37-327. Payment
- 8 of the fee shall be made in a lump sum at the time of application.
- 9 (4) A replacement resident or nonresident lifetime permit
- 10 may be issued if the original has been lost or destroyed. The fee
- 11 for a replacement shall be not less than one dollar and fifty cents
- 12 and not more than five dollars, as established by the commission.
- 13 (5) The commission may adopt and promulgate rules and
- 14 regulations to carry out this section and sections 37-416 and
- 15 37-417. Such rules and regulations may include, but need not be
- 16 limited to, establishing fees which vary based on the age of the
- 17 applicant.
- 18 Sec. 2. Section 37-426, Revised Statutes Supplement,
- 19 2007, is amended to read:
- 20 37-426 (1) Except as provided in subsection (4) of this
- 21 section:
- 22 (a) No resident of Nebraska sixteen years of age or
- 23 older and no nonresident of Nebraska regardless of age shall
- 24 hunt, harvest, or possess any game bird, upland game bird, game
- 25 animal, or fur-bearing animal unless, at the time of such hunting,

1 harvesting, or possessing, such person has an unexpired habitat

- 2 stamp as prescribed by the rules and regulations of the commission
- 3 prior to the time of hunting, harvesting, or possessing such bird
- 4 or animal;
- 5 (b) No resident or nonresident of Nebraska shall take or
- 6 possess any aquatic organism requiring a Nebraska fishing permit,
- 7 including any fish, bullfrog, snapping turtle, tiger salamander,
- 8 or mussel, unless, at the time of such taking or possessing, such
- 9 person has an unexpired aquatic habitat stamp as prescribed by the
- 10 rules and regulations of the commission prior to the time of taking
- 11 or possessing a fish, bullfrog, snapping turtle, tiger salamander,
- 12 or mussel; and
- 13 (c) No resident of Nebraska sixteen years of age or
- 14 older and no nonresident of Nebraska regardless of age shall hunt,
- 15 harvest, or possess any migratory waterfowl unless, at the time
- 16 of such hunting, harvesting, or possessing, such person has an
- 17 unexpired Nebraska migratory waterfowl stamp as prescribed by the
- 18 rules and regulations of the commission prior to the time of
- 19 hunting, harvesting, or possessing such migratory waterfowl.
- 20 (2)(a) The commission may issue a lifetime habitat stamp
- 21 upon application and payment of the appropriate fee. The fee for a
- 22 lifetime habitat stamp shall be twenty times the fee required in
- 23 subsection (5) of this section for an annual habitat stamp. Payment
- 24 of such fee shall be made in a lump sum at the time of application.
- 25 A replacement lifetime habitat stamp may be issued if the original

1 is lost or destroyed. The fee for a replacement shall be not less

- 2 than one dollar and fifty cents and not more than five dollars, as
- 3 established by the commission.
- 4 (b) The commission may issue a lifetime Nebraska
- 5 migratory waterfowl stamp upon application and payment of the
- 6 appropriate fee. The fee for a lifetime Nebraska migratory
- 7 waterfowl stamp shall be twenty times the fee required in
- 8 subsection (5) of this section for an annual Nebraska migratory
- 9 waterfowl stamp. Payment of such fee shall be made in a lump sum at
- 10 the time of application. A replacement Nebraska lifetime migratory
- 11 waterfowl stamp may be issued if the original is lost or destroyed.
- 12 The fee for a replacement shall be not less than one dollar and
- 13 fifty cents and not more than five dollars, as established by the
- 14 commission.
- 15 (3) The commission may issue a lifetime aquatic habitat
- 16 stamp upon application and payment of the appropriate fee. The
- 17 fee for a lifetime aquatic habitat stamp shall be $\frac{1}{1}$
- 18 seventy-five dollars and not more than one hundred twenty-five
- 19 dollars as established by the commission pursuant to section
- 20 37-327. Payment of such fee shall be made in a lump sum at the time
- 21 of application. A lifetime aquatic habitat stamp shall not be made
- 22 invalid by reason of the holder subsequently residing outside the
- 23 state. A replacement lifetime aquatic habitat stamp may be issued
- 24 if the original is lost or destroyed. The fee for a replacement
- 25 shall not be less than one dollar and fifty cents and not more than

1 five dollars, as established by the commission.

2 (4) Habitat stamps are not required for holders of

- 3 limited permits issued under section 37-455. Aquatic habitat stamps
- 4 are not required (a) when a fishing permit is not required,
- 5 (b) for holders of permits pursuant to section 37-424, or (c)
- 6 for holders of lifetime fishing permits or lifetime combination
- 7 hunting and fishing permits purchased prior to January 1, 2006.
- 8 Nebraska migratory waterfowl stamps are not required for hunting,
- 9 harvesting, or possessing any species other than ducks, geese, or
- 10 brant. For purposes of this section, a showing of proof of the
- 11 electronic issuance of a stamp by the commission shall fulfill the
- 12 requirements of this section.
- 13 (5) Any person to whom a stamp has been issued shall,
- 14 immediately upon request, exhibit evidence of issuance of the
- 15 stamp to any officer. Any person hunting, fishing, harvesting,
- 16 or possessing any game bird, upland game bird, game animal, or
- 17 fur-bearing animal or any aquatic organism requiring a fishing
- 18 permit in this state without evidence of issuance of the
- 19 appropriate stamp shall be deemed to be without such stamp. A
- 20 habitat stamp shall be issued upon the payment of a fee of not
- 21 less than thirteen dollars and not more than sixteen dollars per
- 22 stamp. An aquatic habitat stamp shall be issued in conjunction
- 23 with each fishing permit for a fee of not less than five dollars
- 24 and not more than seven dollars and fifty cents per stamp for
- 25 annual fishing permits, three-day fishing permits, or combination

1 hunting and fishing permits and a fee of not less than seventy-five

- 2 dollars and not more than one hundred dollars for lifetime fishing
- 3 or combination hunting and fishing permits. The fee established
- 4 under section 37-407 for a one-day fishing permit shall include an
- 5 aquatic habitat stamp. One dollar from the sale of each one-day
- 6 fishing permit shall be remitted to the State Treasurer for
- 7 credit to the Nebraska Aquatic Habitat Fund. A Nebraska migratory
- 8 waterfowl stamp shall be issued upon the payment of a fee of not
- 9 less than five dollars and not more than ten dollars per stamp. The
- 10 commission shall establish the fees pursuant to section 37-327.
- 11 Sec. 3. Section 37-438, Revised Statutes Cumulative
- 12 Supplement, 2006, is amended to read:
- 13 37-438 (1) The commission shall devise permits in two
- 14 forms: Annual and temporary.
- 15 (2) The annual permit may be purchased by any person
- 16 and shall be valid through December 31 in the year for which the
- 17 permit is issued. The fee for the annual permit for a resident
- 18 motor vehicle shall be not less than fourteen dollars and not more
- 19 than twenty dollars per permit. The fee for the annual permit for
- 20 a nonresident motor vehicle shall not be more than twenty-five
- 21 dollars. The commission shall establish such fees by the adoption
- 22 and promulgation of rules and regulations.
- 23 (3) A temporary permit may be purchased by any person and
- 24 shall be valid until noon of the day following the date of issue.
- 25 The fee for the temporary permit for a resident motor vehicle shall

1 be, until January 1, 2007, not more than three dollars, and on and

- 2 after January 1, 2007, not more than four dollars. The fee for the
- 3 temporary permit for a nonresident motor vehicle shall not be more
- 4 than five dollars. The commission shall establish such fees by the
- 5 adoption and promulgation of rules and regulations. The commission
- 6 may issue temporary permits which are either valid for any area or
- 7 valid for a single area.
- 8 Sec. 4. Section 37-448, Reissue Revised Statutes of
- 9 Nebraska, is amended to read:
- 10 37-448 (1) Subject to rules and regulations adopted and
- 11 promulgated by the commission, the secretary of the commission
- 12 may designate special deer depredation seasons by executive order.
- 13 The secretary may designate a depredation season whenever he or
- 14 she determines that deer are causing excessive property damage.
- 15 The secretary shall specify the number of permits to be issued,
- 16 shooting hours, the length of the depredation season, and the
- 17 geographic area in which hunting will be permitted. Each such
- 18 permit shall give the holder the right to take one deer. Hunting
- 19 during a special depredation season shall be limited to residents
- 20 and shall be restricted to firearms which are permissible for use
- 21 during the regular deer season.
- 22 (2) The depredation season may commence not less than
- 23 five days after the first public announcement that the depredation
- 24 season has been established. Permits shall be issued beginning
- 25 not less than three days after the first public announcement of

1 the depredation season and shall be issued in an impartial manner

- 2 at a location determined by the secretary. The commission shall,
- 3 pursuant to section 37-327, establish and charge a fee of not less
- 4 than twenty dollars and not more than twenty-five dollars for a
- 5 special depredation season permit. Fifty percent of the fee shall
- 6 be paid by the commission to a landowner or operator within the
- 7 designated area upon satisfactory proof a deer was killed upon
- 8 his or her farm or ranch during the special depredation season.
- 9 Receipt of a depredation season permit shall not in any way affect
- 10 a person's eligibility for a regular season permit.
- 11 Sec. 5. Section 37-451, Reissue Revised Statutes of
- 12 Nebraska, is amended to read:
- 13 37-451 The commission may issue permits for hunting
- 14 mountain sheep and may establish separate and, when necessary,
- 15 different regulations therefor within the limitations prescribed in
- 16 subsection (1) of section 37-447 and section 37-452 for hunting
- 17 deer. Such regulations shall include provisions allowing persons
- 18 who find dead mountain sheep, or any part of a mountain sheep,
- 19 to turn over to the commission such mountain sheep or part of a
- 20 mountain sheep. The commission may dispose of such mountain sheep
- 21 or part of a mountain sheep as it deems reasonable and prudent.
- 22 Except as otherwise provided in this section, the permits shall be
- 23 issued to residents of Nebraska. The commission shall, pursuant to
- 24 section 37-327, establish and charge a nonrefundable application
- 25 fee of not less than twenty dollars and not more than twenty-five

1 dollars for permits issued only to residents. Any number of

- 2 resident-only permits, as authorized by the commission, shall be
- 3 awarded by random drawing to eligible applicants. No permit fee
- 4 shall be charged in addition to the nonrefundable application fee.
- 5 No more than one additional permit may be authorized and issued
- 6 pursuant to an auction open to residents and nonresidents. The
- 7 auction shall be conducted according to rules and regulations
- 8 prescribed by the commission. Any money derived from the sale
- 9 of permits by auction shall be used only for perpetuation and
- 10 management of mountain sheep, elk, and deer. If the commission
- 11 determines to limit the number of permits issued for any or all
- 12 management units, the commission shall by rule and regulation
- 13 determine eligibility requirements for the permits. A person may
- 14 obtain only one mountain sheep permit in his or her lifetime.
- 15 Sec. 6. Section 37-458, Reissue Revised Statutes of
- 16 Nebraska, is amended to read:
- 17 37-458 (1) The commission shall, to aid in the protection
- 18 of livestock and other domesticated animals, issue a special permit
- 19 authorizing the holder to use aircraft for the purpose of shooting
- 20 or attempting to shoot coyotes. Such permit shall be issued only
- 21 after it is shown that (a) the coyote population is so large
- 22 in an area as to present a substantial threat to livestock and
- 23 other domesticated animals and (b) property owners will not be
- 24 detrimentally affected by such issuance.
- 25 (2) The annual fee for the permit shall be not less than

1 seven dollars and not more than eight dollars and fifty cents, as

- 2 established by the commission pursuant to section 37-327, and the
- 3 permit shall expire on December 31 following the date of issuance.
- 4 The form of such permit and of the application for the permit shall
- 5 be prescribed by the commission.
- 6 (3) The commission shall adopt and promulgate necessary
- 7 rules and regulations to carry out this section and may designate
- 8 areas in which the coyote population may present a threat or
- 9 cause substantial damage to livestock and restrict the issuance of
- 10 permits only to such areas. The commission, officers and agents of
- 11 the commission, and any other peace officer of this state shall
- 12 have the authority to enforce this section and section 37-509.
- Sec. 7. Section 37-462, Reissue Revised Statutes of
- 14 Nebraska, is amended to read:
- 15 37-462 (1) It shall be unlawful for any person to perform
- 16 taxidermy services on any game for any person other than himself
- 17 or herself without first obtaining a taxidermist permit from
- 18 the commission. The permit shall be conspicuously posted at the
- 19 location where taxidermy services are performed. The application
- 20 for the permit shall include the applicant's social security
- 21 number. The annual fee for such permit shall be not less than
- 22 seven dollars and not more than eight dollars and fifty cents,
- 23 as established by the commission pursuant to section 37-327. Such
- 24 permit shall expire on December 31 of the year for which issued.
- 25 (2) Original application for a taxidermist permit shall

1 be made to the commission upon such form and containing such

- 2 information as may be prescribed by the commission. The application
- 3 shall include the address of the premises where taxidermist
- 4 services will be provided and a statement of the applicant's
- 5 qualifications and experience as a taxidermist. Requests for
- 6 renewals of existing permits shall be made by letter to the
- 7 commission not later than thirty days preceding the expiration date
- 8 of the permit.
- 9 (3) A permit shall authorize a taxidermist to (a)
- 10 receive, transport, hold in custody or possession, mount, or
- 11 otherwise prepare game and return such game to the legal owner or
- 12 his or her agent from whom received and (b) sell game which he or
- 13 she has lawfully acquired and mounted. Such mounted specimens may
- 14 be placed on consignment by the taxidermist for sale and may be
- 15 held by such consignee for the purpose of sale.
- 16 (4) Permitholders shall keep accurate records of
- 17 operations, on a calendar-year basis, showing the names and
- 18 addresses of persons from and to whom specimens of game or the
- 19 nests or eggs of such game were received or delivered, the number
- 20 and species, and the dates of receipt and delivery. In addition to
- 21 other records required by this subsection, the permitholder shall
- 22 maintain proper invoices or other documents confirming his or her
- 23 lawful acquisition of game being held by him or her, including game
- 24 which is on consignment for sale. Permitholders shall retain such
- 25 records not less than one year following the end of the calendar

1 year covered by the records. Such records shall be available for

- 2 inspection by duly authorized employees or agents of the commission
- 3 during normal business hours.
- 4 (5) Any violation of this section shall constitute a
- 5 Class III misdemeanor.
- 6 Sec. 8. Section 37-463, Reissue Revised Statutes of
- 7 Nebraska, is amended to read:
- 8 37-463 (1) It shall be unlawful for any person, firm, or
- 9 corporation dealing in raw furs to conduct such business without
- 10 first obtaining from the commission a fur buyer's permit. If the
- 11 applicant is an individual, the application shall include the
- 12 applicant's social security number. The annual fee for this permit
- 13 shall be not less than one hundred twelve dollars and not more
- 14 than one hundred thirty-eight dollars for residents, as established
- 15 by the commission pursuant to section 37-327. Any resident who
- 16 has resided in this state continuously for a period of six months
- 17 before making an application for a permit under this section shall
- 18 be deemed to be a resident and may be issued a resident permit
- 19 under this section. The fees for nonresidents of this state shall
- 20 be equal to the fees charged for similar permits by the states of
- 21 their respective residences but not less than five hundred dollars
- 22 per annum for such nonresidents. Before a fur buyer's permit is
- 23 issued to a nonresident of this state, the applicant shall execute
- 24 and deliver to the secretary of the commission a corporate surety
- 25 bond, running to the State of Nebraska, in the penal sum of one

1 thousand dollars to be approved by the commission, conditioned

- 2 that the permitholder shall faithfully comply with all the laws of
- 3 this state. Dealers sending buyers into the field away from their
- 4 place of business shall provide each such buyer with a separate
- 5 fur buyer's permit. Every nonresident buyer entering the state or
- 6 who has buyers in this state shall carry a nonresident fur buyer's
- 7 permit.
- 8 (2) Every resident and nonresident fur buyer shall keep
- 9 a complete record of all furs bought or sold in a record book to
- 10 be provided by the commission or any other form of record keeping
- 11 approved by the commission. Such record shall include, but not be
- 12 limited to, the number and kind of furs bought or sold, the name
- 13 and address of the seller or buyer, the date and place of purchase
- 14 or sale, and the permit number of the seller or fur buyer.
- 15 (3) It shall be unlawful for any fur buyer to have
- 16 raw furs in his, her, or its possession unless the record gives
- 17 positive evidence of the origin of such furs and unless such record
- 18 balances at all times. Such record shall be open to inspection
- 19 by conservation officers at any and all times and shall be made
- 20 available to such officers upon demand.
- 21 (4) Any violation of any of the provisions of this
- 22 section shall constitute a Class IV misdemeanor, and as a part of
- 23 the penalty the court shall require the offender to purchase the
- 24 required permit.
- 25 Sec. 9. Section 37-465, Reissue Revised Statutes of

- 1 Nebraska, is amended to read:
- 2 37-465 An application for an aquaculture permit to
- 3 operate an aquaculture facility shall be made to the commission
- 4 on a form prescribed by the commission. The application shall
- 5 include (1) the name, social security number if the applicant is
- 6 an individual, residence, and place of business of the applicant,
- 7 (2) the exact description of the land upon which the facility is
- 8 to be located and the nature of the applicant's title to the land,
- 9 whether in fee or under lease, and (3) the kind and approximate
- 10 number of aquatic organisms authorized to be kept or reared in
- 11 the facility. The annual fee for an aquaculture permit shall be
- 12 not less than sixty-five dollars and not more than seventy-five
- 13 dollars, as established by the commission pursuant to section
- 14 37-327. The permit shall expire at midnight on December 31 in the
- 15 year for which the permit is issued.
- 16 Sec. 10. Section 37-478, Reissue Revised Statutes of
- 17 Nebraska, is amended to read:
- 18 37-478 (1) To conduct an auction in this state of
- 19 captive wild birds, captive wild mammals, or captive wildlife as
- 20 specified in subsection (1) of section 37-477, a person shall
- 21 apply to the commission on a form prescribed by the commission
- 22 for a captive wildlife auction permit. An applicant for a permit
- 23 shall specify the dates of the auction and shall apply for a
- 24 permit for each auction to be held in the state. The application
- 25 for the permit shall include the applicant's social security

1 number. The fee for such permit shall be not less than fifty

- 2 dollars and not more than sixty-five dollars, as established by
- 3 the commission pursuant to section 37-327. The commission shall
- 4 adopt and promulgate rules and regulations specifying application
- 5 requirements and procedures, reporting and inspection requirements,
- 6 and other requirements related to auction activities.
- 7 (2) A permitholder shall not (a) take wild birds, wild

- 9 purchase wild birds, wild mammals, or other wildlife from any
- 10 person other than the commission or a person authorized to
- 11 propagate and dispose of wild birds, wild mammals, or other

- 14 54-701.03.
- 15 Sec. 11. Section 37-479, Reissue Revised Statutes of
- 16 Nebraska, is amended to read:
- 17 37-479 (1) To purchase, possess, propagate, or sell
- 18 captive wild birds, captive wild mammals, or captive wildlife
- 19 as specified in subsection (1) of section 37-477 or to sell
- 20 parts thereof, except as provided in section 37-505, a person
- 21 shall apply to the commission on a form prescribed by the
- 22 commission for a captive wildlife permit. The commission shall
- 23 adopt and promulgate rules and regulations specifying application
- 24 requirements and procedures. The permit shall expire on December
- 25 31. The application for the permit shall include the applicant's

1 social security number. The annual fee for such permit shall be not

- 2 less than twenty-five dollars and not more than thirty dollars, as
- 3 established by the commission pursuant to section 37-327. A holder
- 4 of a captive wildlife permit shall report to the commission by

- 12 birds, wild mammals, or wildlife. A permit under this section is
- 13 not required for possession or production of domesticated cervine
- 14 animals as defined in section 54-701.03.
- 15 Sec. 12. Section 37-483, Reissue Revised Statutes of
- 16 Nebraska, is amended to read:
- 17 37-483 The construction, operation, and maintenance of
- 18 a facility commonly known as a recall pen, also known as a
- 19 recapture pen, which is used for the recapture of marked game
- 20 birds originating from the holder of a captive wildlife permit
- 21 in conjunction with dog training or dog trial activities shall be
- 22 legal if the person owning or controlling such recall pen, prior to
- 23 the operation thereof, pays an annual fee of not less than thirteen
- 24 dollars and not more than fifteen dollars, as established by the
- 25 commission pursuant to section 37-327, for each recall pen under

1 his or her ownership or control. The commission shall adopt and

- 2 promulgate rules and regulations for the issuance of permits for
- 3 recall pens and for the possession and use of recall pens. Nothing

- 10 a term of five or more years, any contiguous tract or tracts of
- 11 land having an area of not less than one hundred twenty acres and
- 12 not more than one thousand two hundred eighty acres who desires
- 13 to establish a game breeding and controlled shooting area to
- 14 propagate, preserve, and shoot game birds under the regulations
- 15 as provided in sections 37-484 to 37-496 shall make application
- 16 to the commission for a license as provided by such sections.
- 17 Such application shall be made under oath of the applicant or
