- 8 67-464 (1) Before January 1, 2001, the Uniform
- 9 Partnership Act of 1998 governs only a partnership formed:
- 10 (a) On or after January 1, 1998, except a partnership
- 11 that is continuing the business of a dissolved partnership under
- 12 section 67-341 as such section existed prior to January 1, 1998;
- 13 and
- 14 (b) Before January 1, 1998, that elects, as provided by
- 15 subsection (3) of this section, to be governed by the act.
- 16 (2) On and after January 1, 2001, the act Uniform
- 17 Partnership Act of 1998 governs all partnerships.
- 18 (3) Before January 1, 2001, a partnership voluntarily

- 6 govern a partnership that becomes a limited liability partnership
- 7 before January 1, 1998, except (a) a partnership that is continuing
- 8 the business of a dissolved limited liability partnership or (b) a
- 9 limited liability partnership that elects, before January 1, 2001,
- 10 in the manner provided by the partnership agreement or by law for
- 11 amending the agreement, to be governed by the act. If an election
- 12 is made, the provisions of the act relating to the liability of
- 13 a partner to a third party apply to limit the partner's liability
- 14 to a third party who had done business with the partnership within
