Nebraska Retirement Systems Committee January 18, 2008

The Committee on Nebraska Retirement Systems met at 8:30 a.m. on Friday, January 18, 2008, in Room 1525 of the State Capitol, Lincoln, Nebraska, for the purpose of conducting a public hearing on gubernatorial appointments. Senators present: John Synowiecki, Chairperson; Philip Erdman; Russ Karpisek; and LeRoy Louden. Senators absent: Tom White, Vice Chairperson, and Lavon Heidemann. [CONFIRMATION]

SENATOR SYNOWIECKI: Welcome, everybody, to the Nebraska Retirement Systems Committee. We will have our...the business of the committee today is for the confirmation hearing for Elaine Stuhr, Public Employees Retirement Board. Members present, to my right is Senator LeRoy Louden. Jeremy Nordquist is the Research Analyst; he's to my immediate right. To my immediate left is Senator Phil Erdman. Laurie Vollertsen is the committee clerk. We will hear first from the confirmee, Senator Elaine Stuhr. Senator, good morning. [CONFIRMATION]

ELAINE STUHR: (Exhibit 1) Good morning. Good morning to you and good morning to the members of the committee. It's good to be here. And for the record, my name is Elaine, E-l-a-i-n-e, Stuhr, S-t-u-h-r. And I just first want to say thank you, Chairman Synowiecki and the staff, for arranging this hearing. Taught for a number of years at Hampton, and then at Henderson Public Schools. I worked for the university, assisting them with student teachers, for about five years. Then I became involved--I'm also sort of a professional volunteer, so to speak--became involved in an organization called Women Involved in Farm Economics. Worked on policy for ag producers, trying to improve their income and their way of life. I served as national president, and I guess that's where I really got involved in the policy end of it. In 1994, I ran for the Legislature. I was elected and I served the next 12 years. I did serve about 10 years on the Retirement Committee, 2 years as Vice Chairman and 6 years as Chairman, so I feel that I have a little bit of an understanding of some of the goings-on of the Retirement System as a whole. And I really appreciate the opportunity to be able to use some of this experience in the position that I have been appointed to. So, very briefly. [CONFIRMATION]
