1 Section 1. Section 71-816, Revised Statutes Cumulative

- 2 Supplement, 2008, is amended to read:
- 3 71-816 (1) The Legislature finds that the main sources
- 4 of funding for the Compulsive Gamblers Assistance Fund are the
- 5 Charitable Gaming Operations Fund as provided in section 9-1,101
- 6 and the State Lottery Operation Trust Fund as provided in section
- 7 9-812 and Article III, section 24, of the Constitution of Nebraska.
- 8 It is the intent of the Legislature that the Compulsive Gamblers
- 9 Assistance Fund be used primarily for counseling and treatment
- 10 services for problem gamblers and their families who are residents
- 11 of Nebraska.
- 12 (2) The State Committee on Problem Gambling is created.
- 13 Members of the committee shall have a demonstrated interest and
- 14 commitment and specialized knowledge, experience, or expertise
- 15 relating to the provision of problem gambling and addiction
- 16 services in the State of Nebraska. The committee shall consist
- 17 of twelve members appointed by the Governor and shall include at
- 18 least three consumers of problem gambling or addiction services.
- 19 The committee shall appoint one of its members as chairperson
- 20 of the committee and other officers as it deems appropriate. The
- 21 committee shall conduct regular meetings and shall meet upon the
- 22 call of the chairperson or a majority of its members to conduct its
- 23 official business.
- 24 (3) The committee shall develop and recommend to
- 25 the division guidelines and standards for the distribution and

- 3 recognized standards for compulsive problem gamblers assistance
- 4 programs.
- 5 (4) In addition, the committee shall develop
- 6 recommendations regarding (a) the evaluation and approval
- 7 process for provider applications and contracts for treatment
- 8 funding from the Compulsive Gamblers Assistance Fund, (b) the
- 9 review and use of evaluation data, (c) the use and expenditure
- 10 of funds for education regarding problem gambling and prevention
- 11 of problem gambling, and (d) the creation and implementation of
- 12 outreach and educational programs regarding problem gambling for
- 13 Nebraska residents. The committee may engage in other activities it
- 14 finds necessary to carry out its duties under this section.
- 15 (5) Based on the recommendations of the committee, the
- 16 division shall adopt guidelines and standards for the distribution
- 17 and disbursement of money in the fund and for administration of
- 18 problem gambling and addiction services in Nebraska.
- 19 (6) The division and the committee shall jointly submit
- 20 a report within sixty days after the end of each fiscal year

created. The fund shall include revenue transferred from the 1 2 State Lottery Operation Trust Fund under section 9-812 and the 3 Charitable Gaming Operations Fund under section 9-1,101 and any other revenue received by the division for credit to the fund from any other public or private source, including, but not 5 6 limited to, appropriations, grants, donations, gifts, devises, 7 bequests, fees, or reimbursements. The division shall administer 8 the fund for the treatment of problem gamblers as recommended by 9 the State Committee on Problem Gambling established under section 10 71-816 and shall spend no more than ten percent of the money 11 appropriated to the fund for administrative costs. The Director 12 of Administrative Services shall draw warrants upon the Compulsive 13 Gamblers Assistance Fund upon the presentation of proper vouchers 14 by the division. Money from the Compulsive Gamblers Assistance Fund 15 shall be used exclusively for the purpose of providing assistance 16 to agencies, groups, organizations, and individuals that provide 17 education, assistance, and counseling to individuals and families 18 experiencing difficulty as a result of problem gambling, to promote the awareness of problem gamblers assistance programs, and to 19 20 pay the costs and expenses of the division and the committee 21 with regard to problem gambling. The division shall not provide 22 any direct services to problem gamblers or their families. Funds 23 appropriated from the Compulsive Gamblers Assistance Fund shall not 24 be granted or loaned to or administered by any regional behavioral 25 health authority unless the authority is a direct provider of

1 a problem gamblers assistance program. Any money in the fund

- 2 available for investment shall be invested by the state investment
- 3 officer pursuant to the Nebraska Capital Expansion Act and the
- 4 Nebraska State Funds Investment Act.
