- FOR AN ACT relating to the Cash Reserve Fund; to amend section

 84-612, Revised Statutes Supplement, 2009, as amended

 by section 7, Legislative Bill 2, One Hundred First

 Legislature, First Special Session, 2009; to provide for

 a transfer as prescribed; and to repeal the original

 section.
- 7 Be it enacted by the people of the State of Nebraska,

Section 1. Section 84-612, Revised Statutes Supplement,

- 2 2009, as amended by section 7, Legislative Bill 2, One Hundred
- 3 First Legislature, First Special Session, 2009, is amended to read:
- 4 84-612 (1) There is hereby created within the state
- 5 treasury a fund known as the Cash Reserve Fund which shall be under
- 6 the direction of the State Treasurer. The fund shall only be used
- 7 pursuant to this section.
- 8 (2) The State Treasurer shall transfer funds from the
- 9 Cash Reserve Fund to the General Fund upon certification by the
- 10 Director of Administrative Services that the current cash balance
- 11 in the General Fund is inadequate to meet current obligations. Such
- 12 certification shall include the dollar amount to be transferred.
- 13 Any transfers made pursuant to this subsection shall be reversed
- 14 upon notification by the Director of Administrative Services that
- 15 sufficient funds are available.
- 16 (3) The State Treasurer, at the direction of the
- 17 budget administrator of the budget division of the Department
- 18 of Administrative Services, shall transfer such amounts not to
- 19 exceed seven million seven hundred fifty-three thousand two hundred
- 20 sixty-three dollars in total from the Cash Reserve Fund to the
- 21 Nebraska Capital Construction Fund between July 1, 2003, and June
- 22 30, 2007.
- 23 (4) The State Treasurer, at the direction of the budget
- 24 administrator, shall transfer an amount equal to the total amount
- 25 transferred pursuant to subsection (3) of this section from the

1 General Fund to the Cash Reserve Fund on or before June 30, 2008.

- 2 (5) In addition to receiving transfers from other funds,
- 3 the Cash Reserve Fund shall receive federal funds received by the
- 4 State of Nebraska for undesignated general government purposes,
- 5 federal revenue sharing, or general fiscal relief of the state.
- 6 (6) On June 15, 2009, the State Treasurer shall transfer
- 7 four million nine hundred ninety thousand five hundred five dollars
- 8 from the Cash Reserve Fund to the General Fund.
- 9 (7) On or before June 16, 2009, the State Treasurer, at
- 10 the direction of the budget administrator, shall transfer fifty
- 11 million dollars from the Cash Reserve Fund to the General Fund.
- 12 (8) The State Treasurer, at the direction of the budget
- 13 administrator, shall transfer such amounts, as certified by the
- 14 Director of Administrative Services, for employee health insurance
- 15 claims and expenses, not to exceed twelve million dollars in total
- 16 from the Cash Reserve Fund to the State Employees Insurance Fund
- 17 between May 1, 2007, and June 30, 2011.
- 18 (9) On July 9, 2007, the State Treasurer shall transfer
- 19 five million dollars from the Cash Reserve Fund to the Job Training
- 20 Cash Fund. The State Treasurer shall transfer from the Job Training
- 21 Cash Fund to the Cash Reserve Fund such amounts as directed in
- 22 section 81-1201.21.
- 23 (10) On July 7, 2008, the State Treasurer shall transfer
- 24 five million dollars from the Cash Reserve Fund to the Job Training
- 25 Cash Fund. The State Treasurer shall transfer from the Job Training

1 Cash Fund to the Cash Reserve Fund such amounts as directed in

- 2 section 81-1201.21.
- 3 (11) On or before June 30, 2009, the State Treasurer
- 4 shall transfer nine million five hundred ninety thousand dollars
- 5 from the Cash Reserve Fund to the Nebraska Capital Construction
- 6 Fund.
- 7 (12) The State Treasurer, at the direction of the budget
- 8 administrator, shall transfer an amount equal to the total amount
- 9 transferred pursuant to subsection (8) of this section from the
- 10 appropriate health insurance accounts of the State Employees
- 11 Insurance Fund in such amounts as certified by the Director of
- 12 Administrative Services to the Cash Reserve Fund on or before June
- 13 30, 2011.
- 14 (13) On July 7, 2009, the State Treasurer shall transfer
- 15 five million dollars from the Cash Reserve Fund to the Roads
- 16 Operations Cash Fund. The Department of Roads shall use such
- 17 funds to provide the required state match for federal funding made
- 18 available to the state through congressional earmarks.
- 19 (14) Within five days after the budget division of the
- 20 Department of Administrative Services notifies the State Treasurer
- 21 that matching fund requirements under section 82-331 have been met,
- 22 the State Treasurer shall transfer one million dollars from the
- 23 Cash Reserve Fund to the Nebraska Cultural Preservation Endowment
- 24 Fund.
- 25 (15) On or before June 15, 2010, the State Treasurer,

1 at the direction of the budget administrator, shall transfer one

- 2 hundred five million dollars from the Cash Reserve Fund to the
- 3 General Fund.
- 4 (16) On or before June 15, 2011, the State Treasurer,
- 5 at the direction of the budget administrator, shall transfer one
- 6 hundred fifty-one million dollars from the Cash Reserve Fund to the
- 7 General Fund.
- 8 (17) On June 15, 2009, the State Treasurer shall transfer
- 9 seven million five hundred thousand dollars from the Cash Reserve
- 10 Fund to the Governor's Emergency Cash Fund.
- 11 (18) On July 7, 2009, the State Treasurer shall
- 12 transfer one million dollars from the Cash Reserve Fund to the
- 13 State Visitors Promotion Cash Fund. The Department of Economic
- 14 Development shall use such funds to provide funding for the
- 15 promotion and support of the hosting of a Special Olympics national
- 16 event by a city of the primary class.
- 17 (19) On or before June 30, 2011, the State Treasurer,
- 18 at the direction of the budget administrator, shall transfer three
- 19 million dollars from the Cash Reserve Fund to the General Fund.
