A BILL

1 FOR AN ACT relating to agriculture; to amend section 2-4901,  
2 Reissue Revised Statutes of Nebraska; to change  
3 membership provisions for the Climate Assessment Response  
4 Committee; to repeal the original section; and to declare  
5 an emergency.

6 Be it enacted by the people of the State of Nebraska,

1           Section 1. Section 2-4901, Reissue Revised Statutes of  
2 Nebraska, is amended to read:

3           2-4901 (1) The Climate Assessment Response Committee is  
4 hereby created. The office of the Governor shall be the lead  
5 agency and shall oversee the committee and its activities. The  
6 committee shall be composed of representatives appointed by the  
7 Governor with the approval of a majority of the Legislature from  
8 livestock producers, crop producers, and the Nebraska Emergency  
9 Management Agency, and the Conservation and Survey Division and  
10 Cooperative Extension Service of the University of Nebraska.  
11 ~~Department of Agriculture, Department of Health and Human Services,~~  
12 ~~Department of Natural Resources, and Governor's Policy Research~~  
13 ~~Office. The Director of Agriculture or his or her designee, the~~  
14 ~~chief executive officer of the Department of Health and Human~~  
15 ~~Services or his or her designee, and the Director of Natural~~  
16 ~~Resources or his or her designee shall be ex officio members~~  
17 ~~of the committee.~~ Representatives from the federal Consolidated  
18 Farm Service Agency and Federal Crop Insurance Corporation may  
19 also serve on the committee at the invitation of the Governor.  
20 ~~The Governor may appoint the~~ chairperson of the Committee on  
21 Agriculture of the Legislature and the chairperson of the Committee  
22 on Natural Resources of the Legislature ~~and~~ shall be nonvoting,  
23 ex officio members of the committee. The Governor may appoint a  
24 member of the Governor's Policy Research Office and any other state  
25 agency representatives or invite any other federal agencies to name

1 representatives as he or she deems necessary. The Governor shall  
2 appoint one of the Climate Assessment Response Committee members  
3 to serve as the chairperson of the committee. Committee members  
4 shall be reimbursed for actual and necessary expenses as provided  
5 in sections 81-1174 to 81-1177.

6 (2) The committee shall meet at least twice each year and  
7 shall meet more frequently (a) at the call of the chairperson, (b)  
8 upon request of a majority of the committee members, and (c) during  
9 periods of drought or other severe climate situations.

10 (3) The chairperson may establish subcommittees and may  
11 invite representatives of agencies other than those with members on  
12 the committee to serve on such subcommittees.

13 (4) Any funds for the activities of the committee and for  
14 other climate-related expenditures may be appropriated directly to  
15 the office of the Governor for contracting with other agencies or  
16 persons for tasks approved by the committee.

17 Sec. 2. Original section 2-4901, Reissue Revised Statutes  
18 of Nebraska, is repealed.

19 Sec. 3. Since an emergency exists, this act takes effect  
20 when passed and approved according to law.
