1	FOR	AN	ACT relating to animals; to amend sections 28-1008
2			and 28-1013, Revised Statutes Supplement, 2009; to
3			adopt the Livestock Animal Welfare Act; to eliminate
4			penalties and provisions relating to bovines and equines;
5			to harmonize provisions; to provide a duty for the
6			Revisor of Statutes; to repeal the original sections;
7			and to outright repeal sections 28-1009.02, 28-1009.03,
8			28-1013.01, and 28-1013.02, Reissue Revised Statutes of
9			Nebraska.

10 Be it enacted by the people of the State of Nebraska,

1	Section 1. <u>Sections 1 to 12 of this act shall be known</u>
2	and may be cited as the Livestock Animal Welfare Act.
3	Sec. 2. For purposes of the Livestock Animal Welfare Act:
4	(1) Abandon means to leave a livestock animal in one's
5	care, whether as owner or custodian, for any length of time without
6	making effective provision for the livestock animal's food, water,
7	or other care as is reasonably necessary for the livestock animal's
8	health;
9	(2) Animal welfare practice means veterinarian practices
10	and animal husbandry practices common to the livestock animal
11	industry, including transport of livestock animals from one
12	location to another;
13	(3) Bovine means a cow, an ox, or a bison;
14	(4) Cruelly mistreat means to knowingly and intentionally
15	kill or cause physical harm to a livestock animal in a manner that
16	is not consistent with animal welfare practices;
17	(5) Cruelly neglect means to fail to provide a livestock
18	animal in one's care, whether as owner or custodian, with food,
19	water, or other care as is reasonably necessary for the livestock
20	animal's health;
21	(6) Equine means a horse, pony, donkey, mule, hinny, or
22	<u>llama;</u>
23	(7) Euthanasia means the destruction of a livestock
24	animal by commonly accepted veterinary practices;
25	(8) Law enforcement officer means any member of the

1	Nebraska State Patrol, any county or deputy sheriff, any member
2	of the police force of any city or village, or any other public
3	official authorized by a city or village to enforce state or
4	local laws, rules, regulations, or ordinances. Law enforcement
5	officer also includes any inspector under the Commercial Dog and
6	Cat Operator Inspection Act to the extent that such inspector may
7	exercise the authority of a law enforcement officer under section
8	28-1012 while in the course of performing inspection activities
9	under the Commercial Dog and Cat Operator Inspection Act;
10	(9) Livestock animal means any bovine, equine, swine,
11	sheep, goats, domesticated cervine animals, ratite birds, or
12	poultry; and
13	(10) Serious injury or illness includes any injury or
14	illness to any livestock animal which creates a substantial risk of
15	death or which causes broken bones, prolonged impairment of health,
16	or prolonged loss or impairment of the function of any bodily
17	organ.
18	Sec. 3. (1) A person who intentionally, knowingly, or
19	recklessly abandons or cruelly neglects a livestock animal is
20	guilty of a Class I misdemeanor unless the abandonment or cruel
21	neglect results in serious injury or illness or death of the
22	livestock animal, in which case it is a Class IV felony.
23	(2) A person who cruelly mistreats a livestock animal is
24	guilty of a Class I misdemeanor for the first offense and a Class
25	IV felony for any subsequent offense.

1	Sec. 4. <u>A person commits indecency with a livestock</u>
2	animal when such person subjects an animal to sexual penetration as
3	defined in section 28-318. Indecency with a livestock animal is a
4	<u>Class III misdemeanor.</u>
5	Sec. 5. (1) In addition to any other sentence given for
6	a violation of section 3 or 4 of this act, the sentencing court
7	may order the defendant to reimburse a public or private agency
8	for expenses incurred in conjunction with the care, impoundment,
9	or disposal of a livestock animal involved in the violation of
10	such section. Whenever the court believes that such reimbursement
11	is a proper sentence or at the prosecuting attorney's request,
12	the court shall order that the presentence investigation report
13	include documentation regarding the nature and amount of the
14	expenses incurred. The court may order that reimbursement be made
15	immediately, in specified installments, or within a specified
16	period of time, not to exceed five years after the date of
17	judgment.
18	(2) Even if reimbursement for expenses is not ordered
19	under subsection (1) of this section, the defendant shall be
20	liable for all expenses incurred by a public or private agency in
21	conjunction with the care, impoundment, or disposal of a livestock
22	animal. The expenses shall be a lien upon the livestock animal.
23	Sec. 6. (1) Any law enforcement officer who has reason
24	to believe that a livestock animal has been abandoned or is
25	being cruelly neglected or cruelly mistreated may seek a warrant

1 authorizing entry upon private property to inspect, care for, or 2 impound the livestock animal or livestock animals. 3 (2) Any law enforcement officer who has reason to believe that a livestock animal has been abandoned or is being cruelly 4 5 neglected or cruelly mistreated may issue a citation to the owner 6 as prescribed in sections 29-422 to 29-429. 7 (3) Any livestock animal, equipment, device, or other 8 property or things involved in a violation of section 3 or 4 9 of this act shall be subject to seizure, and distribution or 10 disposition may be made in such manner as the court may direct. 11 (4) Any law enforcement officer acting under this section 12 shall not be liable for damage to property if such damage is not 13 the result of the officer's negligence. 14 Sec. 7. The Livestock Animal Welfare Act shall not apply 15 to: (1) Care or treatment of a livestock animal or other 16 conduct by a veterinarian or veterinary technician licensed under 17 18 the Veterinary Medicine and Surgery Practice Act that occurs within 19 the scope of his or her employment, that occurs while acting in his 20 or her professional capacity, or that conforms to commonly accepted 21 veterinary practices; 22 (2) Euthanasia of a livestock animal or livestock animals 23 as conducted by the owner or by his or her agent or a veterinarian 24 upon the owner's request; 25 (3) Research activity carried on by any research facility

14	Sec. 8. (1) For purposes of this section:
15	(a) Employee means any employee of a governmental agency
16	dealing with livestock animal control or animal abuse; and
17	(b) Reasonably suspects means a basis for reporting
18	knowledge or a set of facts that would lead a person of ordinary
19	care and prudence to believe and conscientiously entertain a strong
20	suspicion that criminal activity is at hand or that a crime has
21	been committed.
22	(2) Any employee, while acting in his or her professional
23	capacity or within the scope of his or her employment, who
24	observes or is involved in an incident which leads the employee
25	to reasonably suspect that a livestock animal has been abandoned,

<u>cruelly neglected</u>, or <u>cruelly mistreated shall report such to</u>
 <u>the entity or entities that investigate such reports in that</u>
 <u>jurisdiction</u>.

4 <u>(3) The report of an employee shall be made within two</u> 5 working days of acquiring the information concerning the livestock 6 animal by facsimile transmission of a written report presented 7 in the form described in subsection (5) of this section or by 8 telephone. When an immediate response is necessary to protect the 9 health and safety of the livestock animal or others, the report of 10 an employee shall be made by telephone as soon as possible.

11 (4) Nothing in this section shall be construed to impose 12 a duty to investigate observed or reasonably suspected livestock 13 animal abandonment, cruel neglect, or cruel mistreatment. Any 14 person making a report under this section is immune from liability 15 except for false statements of fact made with malicious intent.

16 (5) A report made by an employee pursuant to this section
17 shall include:

18 (a) The reporter's name and title, business address, and 19 telephone number;

20 (b) The name, if known, of the livestock animal owner or 21 custodian, whether a business or individual;

(c) A description of the livestock animal or livestock
 animals involved, person or persons involved, and location of the
 livestock animal or livestock animals and the premises; and
 (d) The date, the time, and a description of the

1 observation or incident which led the reporter to reasonably
2 suspect livestock animal abandonment, cruel neglect, or cruel
3 mistreatment and any other information the reporter believes may be
4 relevant.

5 (6) A report made by an employee pursuant to this section 6 may be made on preprinted forms prepared by the entity or entities 7 that investigate reports of livestock animal abandonment, livestock 8 animal cruel neglect, or livestock animal cruel mistreatment in 9 that jurisdiction. The form shall include space for the information 10 required under subsection (5) of this section.

11 <u>(7) When two or more employees jointly have observed or</u> 12 reasonably suspected livestock animal abandonment, livestock animal 13 cruel neglect, or livestock animal cruel mistreatment and there is 14 agreement between or among them, a report may be made by one person 15 by mutual agreement. Any such reporter who has knowledge that the 16 person designated to report has failed to do so shall thereafter 17 make the report.

18 (8) Any employee failing to report under this section
19 shall be guilty of an infraction.

20 Sec. 9. (1) If a person is convicted of a Class IV felony 21 under section 3 of this act, the sentencing court shall order such 22 person not to own or possess a livestock animal for at least five 23 years after the date of conviction, but such time restriction shall 24 not exceed fifteen years. Any person violating such court order 25 shall be guilty of a Class I misdemeanor.

1	(2) If a person is convicted of a Class I misdemeanor
2	under section 3 of this act or a Class III misdemeanor under
3	section 4 of this act, the sentencing court may order such person
4	not to own or possess any livestock animal after the date of
5	conviction, but such time restriction, if any, shall not exceed
6	five years. Any person violating such court order shall be guilty
7	<u>of a Class IV misdemeanor.</u>
8	(3) Any livestock animal involved in a violation of a
9	court order under subsection (1) or (2) of this section shall be
10	subject to seizure by law enforcement.
11	Sec. 10. <u>(1) Any livestock animal health care</u>
12	professional, while acting in his or her professional capacity or
13	within the scope of his or her employment, who observes or is
14	involved in an incident which leads the livestock animal health
15	care professional to reasonably suspect that a livestock animal
16	has been abandoned, cruelly neglected, or cruelly mistreated shall
17	report such treatment to an entity that investigates such reports
18	in the appropriate jurisdiction.
19	(2) Nothing in this section shall be construed to impose
20	a duty to investigate observed or reasonably suspected abandonment,
21	cruel neglect, or cruel mistreatment of a livestock animal. Any
22	person making a report under this section is immune from liability
23	except for false statements of fact made with malicious intent.
24	(3) For purposes of this section, a livestock animal
25	health care professional means a licensed veterinarian as defined

<u>in section 38-3310 or a licensed veterinary technician as defined</u>
 <u>in section 38-3311 whose practice involves care of livestock</u>
 animals.

Sec. 11. (1) No person shall intentionally trip or cause 4 to fall, or lasso or rope the legs of, any equine by any means 5 6 for the purpose of entertainment, sport, practice, or contest. The 7 intentional tripping or causing to fall, or lassoing or roping the 8 legs of, any equine by any means for the purpose of entertainment, 9 sport, practice, or contest shall not be considered a commonly 10 accepted practice occurring in conjunction with sanctioned rodeos, 11 animal racing, or pulling contests.

12 (2) Violation of this section is a Class I misdemeanor. 13 Sec. 12. (1) No person shall intentionally trip, cause to 14 fall, or drag any bovine by its tail by any means for the purpose 15 of entertainment, sport, practice, or contest. The intentional 16 tripping, causing to fall, or dragging of any bovine by its tail 17 by any means for the purpose of entertainment, sport, practice, 18 or contest shall not be considered a commonly accepted practice 19 occurring in conjunction with sanctioned rodeos, animal racing, or 20 pulling contests. 21 (2) Violation of this section is a Class I misdemeanor.

Mutilation does not include conduct 10 performed by a veterinarian licensed to practice veterinary 11 medicine and surgery in this state or conduct that conforms to 12 accepted veterinary practices;

13 (10) (8) Police animal means a horse or dog owned or 14 controlled by the State of Nebraska for the purpose of assisting a 15 Nebraska state trooper in the performance of his or her official 16 enforcement duties;

17 (11) (9) Repeated beating means intentional successive 18 strikes to an animal by a person resulting in serious bodily injury 19 or death to the animal;

20 (12) (10) Serious injury or illness includes any injury 21 or illness to any animal which creates a substantial risk of death 22 or which causes broken bones, prolonged impairment of health, or 23 prolonged loss or impairment of the function of any bodily organ; 24 and

25 (13) (11) Torture means intentionally subjecting an
