### A BILL

- FOR AN ACT relating to community colleges; to amend sections

  85-1502 and 85-2229, Reissue Revised Statutes of

  Nebraska; to require compliance with association

  requirements for payment of state aid as prescribed;

  to harmonize provisions; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 85-1502, Reissue Revised Statutes of

- 2 Nebraska, is amended to read:
- 3 85-1502 (1) It is the intent of the Legislature
- 4 that a clear distinction between area governance and statewide
- 5 coordination for the community college areas be recognized and
- 6 that such coordination is appropriate in order to provide the most
- 7 cost-effective programs for residents of each community college
- 8 area. It is further the intent of the Legislature that coordination
- 9 of the community colleges by the Coordinating Commission for
- 10 Postsecondary Education be conducted through an association of the
- 11 boards.
- 12 (2) All of the boards shall be a part of and shall be
- 13 represented by such association. Coordination services provided
- 14 by such association shall include (a) preparation of a system
- 15 strategic plan, (b) coordination of the budget request for
- 16 the biennium, (c) facilitation of program-needs assessment
- 17 and articulation, (d) recommendation and facilitation of the
- 18 appointment of representatives to committees, boards, commissions,
- 19 task forces, and any other state-level bodies requesting or
- 20 requiring participation from the community college system, and (e)
- 21 facilitation of responses to data and information requests for the
- 22 system.
- 23 (3) All activities conducted pursuant to this section by
- 24 such association shall be conducted in accordance with the Open
- 25 Meetings Act.

1 (4) Nothing in this section shall be construed to require

- 2 or provide for state control of the operations of any community
- 3 college area or to abridge the governance ability, rights, or
- 4 responsibilities of any board. Nothing in this section shall be
- 5 construed to limit the ability or authority of the commission to
- 6 fulfill its responsibilities and duties regarding the individual
- 7 community college areas and the individual community college area
- 8 campuses.
- 9 (5) A community college area which has not met the
- 10 association membership requirements of this section is not
- 11 eligible to receive aid payments pursuant to the Community
- 12 College Foundation and Equalization Aid Act until such membership
- 13 <u>requirements are met.</u>
- 14 Sec. 2. Section 85-2229, Reissue Revised Statutes of
- 15 Nebraska, is amended to read:
- 16 85-2229 The Director of Administrative Services shall,
- 17 upon notification by the State Treasurer that sufficient funds
- 18 are available for payment, draw warrants on vouchers presented by
- 19 the budget division of the Department of Administrative Services
- 20 against funds appropriated and deliver such warrants to the various
- 21 community colleges. The director shall withhold payment from any
- 22 community college area that has not met the membership requirements
- 23 established by section 85-1502 until such membership requirements
- 24 are satisfied.
