

## LEGISLATIVE BILL 219A

Approved by the Governor May 29, 2009

Introduced by Flood, 19.

FOR AN ACT relating to appropriations; to appropriate funds to aid in carrying out the provisions of Legislative Bill 219, One Hundred First Legislature, First Session, 2009; to reduce an appropriation; to provide an operative date; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

Section 1. There is hereby appropriated (1) \$150,734 from the Roads Operations Cash Fund and \$2,648,418 from federal funds for FY2009-10 and (2) \$150,734 from the Roads Operations Cash Fund and \$2,648,418 from federal funds for FY2010-11 to the Department of Roads, for Program 568, to aid in carrying out the provisions of Legislative Bill 219, One Hundred First Legislature, First Session, 2009.

Total expenditures for permanent and temporary salaries and per diems from funds appropriated in this section shall not exceed \$392,540 for FY2009-10 or \$392,540 for FY2010-11.

There is included in the appropriation to this program for FY2009-10 \$1,907,898 federal funds estimate for state aid, which shall only be used for such purpose. Sec. 2. The appropriation for FY2009-10 to the Department of Motor Vehicles, for Program 644 - Highway Safety, shall be reduced by \$150,734 cash funds and \$2,648,418 federal funds estimate. The unexpended cash fund and federal fund appropriation balances existing on June 30, 2009, are hereby reappropriated to Program 644 to meet FY2008-09 obligations. Any reappropriated balances remaining after FY2008-09 obligations have been met shall be transferred to the Department of Roads, for Program 568, no later than September 30, 2009.

The reductions made by this section are made to aid in carrying out the provisions of Legislative Bill 219, One Hundred First Legislature, First Session, 2009.

Sec. 3. This act becomes operative on July 1, 2009.

Sec. 4. Since an emergency exists, this act takes effect when passed and approved according to law.
