LB 1039 relates to violations of school bus safety requirements. The bill establishes a mandatory \$500 penalty for a school bus safety violation and provides for points to be assessed on a motor vehicle operator's license for persons guilty of a violation.

The Department of Motor Vehicles indicates the bill will have no fiscal impact for the department to add an additional traffic violation to the point system.

Individuals convicted of bus safety violations will pay a \$500 fine pursuant to the bill. The current minimum fine for a person guilty of a bus safety violation is \$100 and the maximum fine is \$500. Assuming not all individuals incurring bus safety violations are currently fined the maximum amount, the bill will result in an increase in fine revenue. Revenue from fines accrues to the county where the violation occurs for use by public schools. The Supreme Court indicates there were 108 violations of school bus safety provisions in 2011. Assuming a like number of violations and a minimum fine of \$100, if the bill had been in effect, fine revenue for school districts would have increased by \$43,200.
