A BILL

FOR AN ACT relating to schools; to amend sections 79-720, 79-722, 79-760.04, 79-760.05, 79-1044, 79-1047, 79-1051, 79-1108, 2 and 79-1108.02, Reissue Revised Statutes of Nebraska, and 3 sections 9-812, 79-8,133, 79-8,137.01, 79-8,137.05, 4 79-8,139, 79-1012, and 79-2104.02, Revised Statutes 5 Cumulative Supplement, 2010; to change and eliminate 6 7 allocation provisions relating to the Education Innovation Fund; to change provisions relating to 8 multicultural education, the Attracting Excellence to 9 Teaching Program, the Enhancing Excellence in Teaching 10 Program, and allocation and transfer of certain funds as 11 prescribed; to eliminate provisions relating to a student 12 achievement coordinator; to harmonize provisions; to 13 14 repeal the original sections; to outright repeal section 15 79-11,150, Reissue Revised Statutes of Nebraska; and to 16 declare an emergency.

1 Be it enacted by the people of the State of Nebraska,

Section 1. Section 9-812, Revised Statutes Cumulative

- 2 Supplement, 2010, is amended to read:
- 3 9-812 (1) All money received from the operation of
- 4 lottery games conducted pursuant to the State Lottery Act in Nebraska
- 5 shall be credited to the State Lottery Operation Trust Fund, which
- 6 fund is hereby created. All payments of the costs of establishing and
- 7 maintaining the lottery games shall be made from the State Lottery
- 8 Operation Cash Fund. In accordance with legislative appropriations,
- 9 money for payments for expenses of the division shall be transferred
- 10 from the State Lottery Operation Trust Fund to the State Lottery
- 11 Operation Cash Fund, which fund is hereby created. All money
- 12 necessary for the payment of lottery prizes shall be transferred from
- 13 the State Lottery Operation Trust Fund to the State Lottery Prize
- 14 Trust Fund, which fund is hereby created. The amount used for the
- 15 payment of lottery prizes shall not be less than forty percent of the
- 16 dollar amount of the lottery tickets which have been sold.
- 17 (2) Beginning October 1, 2003, a portion of the dollar
- 18 amount of the lottery tickets which have been sold on an annualized
- 19 basis shall be transferred from the State Lottery Operation Trust
- 20 Fund to the Education Innovation Fund, the Nebraska Opportunity Grant
- 21 Fund, the Nebraska Environmental Trust Fund, the Nebraska State Fair
- 22 Board, and the Compulsive Gamblers Assistance Fund. The dollar amount
- 23 transferred pursuant to this subsection shall equal the greater of
- 24 (a) the dollar amount transferred to the funds in fiscal year 2002-03
- 25 or (b) any amount which constitutes at least twenty-two percent and

1 no more than twenty-five percent of the dollar amount of the lottery

- 2 tickets which have been sold on an annualized basis. To the extent
- 3 that funds are available, the Tax Commissioner and director may
- 4 authorize a transfer exceeding twenty-five percent of the dollar
- 5 amount of the lottery tickets sold on an annualized basis.
- 6 (3) Of the money available to be transferred to the
- 7 Education Innovation Fund, the Nebraska Opportunity Grant Fund, the
- 8 Nebraska Environmental Trust Fund, the Nebraska State Fair Board, and
- 9 the Compulsive Gamblers Assistance Fund:
- 10 (a) The first five hundred thousand dollars shall be
- 11 transferred to the Compulsive Gamblers Assistance Fund to be used as
- 12 provided in section 71-817;
- 13 (b) Nineteen and three-fourths percent of the money
- 14 remaining after the payment of prizes and operating expenses and the
- 15 initial transfer to the Compulsive Gamblers Assistance Fund shall be
- 16 transferred to the Education Innovation Fund;
- 17 (c) Twenty-four and three-fourths percent of the money
- 18 remaining after the payment of prizes and operating expenses and the
- 19 initial transfer to the Compulsive Gamblers Assistance Fund shall be
- 20 transferred to the Nebraska Opportunity Grant Fund;
- 21 (d) Forty-four and one-half percent of the money
- 22 remaining after the payment of prizes and operating expenses and the
- 23 initial transfer to the Compulsive Gamblers Assistance Fund shall be
- 24 transferred to the Nebraska Environmental Trust Fund to be used as
- 25 provided in the Nebraska Environmental Trust Act;

(e) Ten percent of the money remaining after the payment 1 2 of prizes and operating expenses and the initial transfer to the 3 Compulsive Gamblers Assistance Fund shall be transferred to the Nebraska State Fair Board if the most populous city within the county 4 5 in which the fair is located provides matching funds equivalent to ten percent of the funds available for transfer. Such matching funds 6 7 may be obtained from the city and any other private or public entity, 8 except that no portion of such matching funds shall be provided by the state. If the Nebraska State Fair ceases operations, ten percent 9 of the money remaining after the payment of prizes and operating 10 expenses and the initial transfer to the Compulsive Gamblers 11 12 Assistance Fund shall be transferred to the General Fund; and 13 (f) One percent of the money remaining after the payment of prizes and operating expenses and the initial transfer to the 14 Compulsive Gamblers Assistance Fund shall be transferred to the 15 Compulsive Gamblers Assistance Fund to be used as provided in section 16 17 71-817. (4)(a) The Education Innovation Fund is created. At least 18 seventy-five percent of the lottery proceeds allocated to the 19 20 Education Innovation Fund shall be available for disbursement. 21 (b) For fiscal year 2005-06, the Education Innovation 22 Fund shall be allocated as follows: The first one million dollars 23 shall be transferred to the School District Reorganization Fund, and 24 the remaining amount shall be allocated to the General Fund after 25 operating expenses for the Excellence in Education Council are

1 deducted.

2 (c) For fiscal year 2006-07, the Education Innovation Fund shall be allocated as follows: The first two hundred fifty 3 4 thousand dollars shall be transferred to the Attracting Excellence to 5 Teaching Program Cash Fund to fund the Attracting Excellence to 6 Teaching Program Act, the next one million dollars shall be 7 transferred to the School District Reorganization Fund, and the 8 amount remaining in the Education Innovation Fund shall be allocated, 9 after administrative expenses, for distance education equipment and 10 incentives pursuant to sections 79-1336 and 79-1337. 11 (d) For fiscal year 2007-08, the Education Innovation 12 Fund shall be allocated as follows: The first five hundred thousand 13 dollars shall be transferred to the Attracting Excellence to Teaching 14 Program Cash Fund to fund the Attracting Excellence to Teaching 15 Program Act, and the amount remaining in the Education Innovation 16 Fund shall be allocated, after administrative expenses, for distance 17 education equipment and incentives pursuant to sections 79-1336 and 79-1337. 18 19 (e) For fiscal year 2008-09, the Education Innovation 20 Fund shall be allocated as follows: The first seven hundred fifty 21 thousand dollars shall be transferred to the Attracting Excellence to 22 Teaching Program Cash Fund to fund the Attracting Excellence to 23 Teaching Program Act, and the amount remaining in the Education 24 Innovation Fund shall be allocated, after administrative expenses, 25 for distance education equipment and incentives pursuant to sections

1 79-1336 and 79-1337.

2 (f) For fiscal year 2009-10, the Education Innovation 3 Fund shall be allocated as follows: Any amounts transferred to the 4 Education Innovation Fund from the School District Reorganization 5 Fund shall be returned to the School District Reorganization Fund 6 first, the next one million dollars shall be transferred to the 7 Excellence in Teaching Cash Fund to fund the Excellence in Teaching 8 Act, and the amount remaining in the Education Innovation Fund shall 9 be allocated, after administrative expenses, for distance education 10 equipment and incentives pursuant to sections 79-1336 and 79-1337. (g) (b) For fiscal years year 2010-11, through 2015-16, 11 12 the Education Innovation Fund shall be allocated as follows: The 13 first one million dollars shall be transferred to the Excellence in Teaching Cash Fund to fund the Excellence in Teaching Act, and the 14 15 amount remaining in the Education Innovation Fund shall be allocated, 16 after administrative expenses, for distance education equipment and incentives pursuant to sections 79-1336 and 79-1337. 17 (c) For fiscal year 2011-12, the Education Innovation 18 19 Fund shall be allocated as follows: (i) The first two hundred twenty-20 five thousand dollars shall be transferred to the Excellence in 21 Teaching Cash Fund to fund the Attracting Excellence to Teaching 22 Program; (ii) the next three million three hundred sixty-five thousand nine hundred sixty-two dollars shall be distributed to 23 24 school districts as grants pursuant to the Early Childhood Education Grant Program; (iii) the next two million one hundred seventy-five 25

thousand six hundred seventy-three dollars shall be distributed to 1 2 local systems as grants for approved accelerated or differentiated 3 curriculum programs for students identified as learners with high 4 ability pursuant to section 79-1108.02; (iv) the next four hundred 5 ninety-one thousand five hundred forty-one dollars shall be used by the State Department of Education for the development of an 6 7 integrated early childhood, elementary, secondary, and postsecondary 8 student information system; (v) the next four hundred fifty thousand 9 dollars shall fund the Center for Student Leadership and Extended 10 Learning Act; (vi) the next one hundred fourteen thousand six hundred twenty-nine dollars shall fund the multicultural education program 11 12 created under section 79-720; (vii) the next one hundred twenty-three 13 thousand four hundred sixty-eight dollars shall be used by the 14 department to employ persons to investigate and prosecute alleged 15 violations as provided in section 79-868; and (viii) the amount 16 remaining shall be allocated, after administrative expenses, for 17 distance education equipment and incentives pursuant to sections 18 79-1336 and 79-1337. (d) For fiscal year 2012-13, the Education Innovation 19 20 Fund shall be allocated as follows: (i) The first forty-five thousand 21 dollars shall be transferred to the Excellence in Teaching Cash Fund 22 to fund the Attracting Excellence to Teaching Program; (ii) the next three million three hundred sixty-five thousand nine hundred sixty-23 two dollars shall be distributed to school districts as grants 24 25 pursuant to the Early Childhood Education Grant Program; (iii) the

next two million one hundred seventy-five thousand six hundred 1 2 seventy-three dollars shall be distributed to local systems as grants 3 for approved accelerated or differentiated curriculum programs for 4 students identified as learners with high ability pursuant to section 5 79-1108.02; (iv) the next one hundred eight thousand one hundred thirty-six dollars shall be used by the department for the 6 7 development of an integrated early childhood, elementary, secondary, 8 and postsecondary student information system; (v) the next four 9 hundred fifty thousand dollars shall fund the Center for Student 10 Leadership and Extended Learning Act; (vi) the next one hundred fourteen thousand six hundred twenty-nine dollars shall be used by 11 12 the department to fund the multicultural education program created 13 under section 79-720; (vii) the next one hundred twenty-three thousand four hundred sixty-eight dollars shall be used by the 14 15 department to employ persons to investigate and prosecute alleged violations as provided in section 79-868; and (viii) the amount 16 17 remaining shall be allocated, after administrative expenses, for distance education equipment and incentives pursuant to sections 18 79-1336 and 79-1337. 19 20 (e) For fiscal years 2013-14 through 2015-16, the 21 Education Innovation Fund shall be allocated as follows: (i) The 22 first one million dollars shall be transferred to the Excellence in Teaching Cash Fund to fund the Excellence in Teaching Act; (ii) the 23 24 next allocation shall be distributed to local systems as grants for approved accelerated or differentiated curriculum programs for 25

1 students identified as learners with high ability pursuant to section 79-1108.02 in an aggregated amount up to the amount distributed in 2 3 the prior fiscal year for such purposes increased by the basic 4 allowable growth rate pursuant to section 79-1025; (iii) the next 5 allocation shall be used by the State Department of Education for the integrated early childhood, elementary, secondary, and postsecondary 6 7 student information system in an aggregated amount up to the amount 8 used in the prior fiscal year for such purposes increased by the 9 basic allowable growth rate pursuant to section 79-1025; (iv) the 10 next allocation shall fund the Center for Student Leadership and 11 Extended Learning Act in an aggregated amount up to the amount used 12 in the prior fiscal year for such purposes increased by the basic 13 allowable growth rate pursuant to section 79-1025; (v) the next 14 allocation shall be used by the department to fund the multicultural 15 education program created under section 79-720 in an aggregated 16 amount up to the amount used in the prior fiscal year for such 17 purposes increased by the basic allowable growth rate pursuant to 18 section 79-1025; (vi) the next allocation shall be used by the department to employ persons to investigate and prosecute alleged 19 20 violations as provided in section 79-868 in an aggregated amount up 21 to the amount used in the prior fiscal year for such purposes 22 increased by the basic allowable growth rate pursuant to section 79-1025; and (vii) the amount remaining shall be allocated, after 23 administrative expenses, for distance education equipment and 24 25 incentives pursuant to sections 79-1336 and 79-1337.
