A BILL

- 1 FOR AN ACT relating to schools; to amend section 79-769, Reissue
- 2 Revised Statutes of Nebraska; to change provisions
- 3 relating to focus schools, focus programs, and magnet
- 4 schools; and to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 79-769, Reissue Revised Statutes of
2 Nebraska, is amended to read:

3 79-769 (1) Any one or more member school districts of a
4 learning community may establish one or more focus programs, focus
5 schools, or magnet schools. If included as part of the diversity plan
6 of a learning community, the focus school or focus program shall be
7 eligible for a focus school and program allowance pursuant to section
8 79-1007.05. pursuant to the diversity plan developed by the learning
9 community coordinating council.

10 (2) Focus schools, focus programs, and magnet schools may
11 be included in pathways across member school districts pursuant to
12 the diversity plan developed by the learning community coordinating
13 council pursuant to section 79-2104.

14 (3) If multiple member school districts collaborate on a
15 focus program, focus school, or magnet school, ~~one member school~~
16 ~~district shall be designated as the primary school district. The~~
17 ~~primary school district shall maintain legal, financial, and academic~~
18 ~~responsibility for such focus program, focus school, or magnet~~
19 ~~school. the school districts shall form a joint entity pursuant to~~
20 ~~the Interlocal Cooperation Act for the purpose of creating,~~
21 ~~implementing, and operating such focus program, focus school, or~~
22 ~~magnet school. The agreement creating such joint entity shall address~~
23 ~~legal, financial, and academic responsibilities and the assignment to~~
24 ~~participating school districts of students enrolled in such focus~~
25 ~~program, focus school, or magnet school who reside in~~

1 nonparticipating school districts.

2 (4) For purposes of this section:

3 (a) Focus program means a program that does not have an
4 attendance area, whose enrollment is designed so that the
5 socioeconomic diversity of the students attending the focus program
6 reflects as nearly as possible the socioeconomic diversity of the
7 student body of the learning community, which has a unique curriculum
8 with specific learning goals or teaching techniques different from
9 the standard curriculum, which may be housed in a building with other
10 public school programs, and which may consist of either the complete
11 education program for participating students or part of the education
12 program for participating students;

13 (b) Focus school means a school that does not have an
14 attendance area, whose enrollment is designed so that the
15 socioeconomic diversity of the students attending the focus school
16 reflects as nearly as possible the socioeconomic diversity of the
17 student body of the learning community, which has a unique curriculum
18 with specific learning goals or teaching techniques different from
19 the standard curriculum, and which is housed in a building that does
20 not contain another public school program;

21 (c) Magnet school means a school having a home attendance
22 area but which reserves a portion of its capacity specifically for
23 students from outside the attendance area who will contribute to the
24 socioeconomic diversity of the student body of such school and which
25 has a unique curriculum with specific learning goals or teaching

1 techniques different from the standard curriculum; and

2 (d) Pathway means elementary, middle, and high school
3 focus programs, focus schools, and magnet schools with coordinated
4 curricula based on specific learning goals or teaching techniques.
