Section 1. Section 37-1241.06, Reissue Revised Statutes
 of Nebraska, is amended to read:

3 37-1241.06 (1)(a) No person under fourteen years of age
4 shall operate a motorboat or personal watercraft on the waters of
5 this state.

6 (b) No person under sixteen years of age shall operate a 7 motorboat or personal watercraft on the waters of this state with an 8 individual in tow behind the motorboat or personal watercraft.

9 (2) Effective May 1, 2000, and until January 1, 2004, a 10 person under sixteen years of age shall not operate a motorboat or 11 personal watercraft on the waters of this state unless he or she has 12 successfully completed a boating safety course approved by the 13 commission and has been issued a valid boating safety certificate.

14 (3) (2) Effective January 1, 2004, a 2012, no person 15 under eighteen years of age born after December 31, 1985, shall not 16 operate a motorboat or personal watercraft on the waters of this 17 state unless he or she has successfully completed a boating safety 18 course approved by the commission and has been issued a valid boating 19 certificate.

20 (4) (3) The commission may charge a fee of no more than
21 ten dollars for a boating safety course required by this section.
