The Nebraska Investment Finance Authority (the “Authority”) hereby gives notice in accordance with the Nebraska Investment Finance Authority Act, Neb. Rev. Stat. §§ 58-201 et seq., as amended (the “Act”), to the Honorable Dave Heineman, Governor of the State of Nebraska (the “State”), and Patrick J. O’Donnell, Clerk of the Legislature, following the issuance by the Authority of the following bonds:
